

# THIS IS AN EMERGENCY

In England, 280,000 people do not have a permanent home - which can mean sleeping on the streets, on a sofa, or in cramped B&Bs and hostels.

Thousands of people are facing illegal evictions, repossession, or enduring housing conditions that are detrimental to their health. Millions more are at risk of losing their homes because of financial hardship and limited protection for renters.

Legal support can be the difference between losing your home or keeping it.



# MAKING SURE EVERYONE HAS ACCESS TO JUSTICE

Funding cuts have seen free housing advice nearly disappear in over half of all local authorities in England and Wales. This leaves thousands of people without the help they are legally entitled to and they are losing their homes as a result.

Our legal expertise shapes everything we do, from informing people of their rights to guiding our campaigning strategy. We help hundreds of thousands of people each year, providing critical legal advice, advocacy and representation in court.

## DEFENDING HOME

Dimple Patel, Managing Solicitor at Shelter Birmingham, is waiting at court to meet her first client.

Some days, she could have 12 hearings to defend people in the space of two and a half hours. Five minutes may be all she has to take instructions from her client, form an argument, and then go before the judge to defend them from eviction.

It's just another day for Dimple but can be life-changing for each person she sees.

## SAM'S CASE

"I met Sam, a care leaver who was being evicted because of rent arrears. Usually, a person in these circumstances will lose their home. But I was able to find grounds to defend him.

Hearing what Sam had been through was heart-wrenching. Sam had been abused by his father, and his mother had been sectioned on more than one occasion. Even the housing officer trying to gain possession of his property was in tears.

I managed to negotiate with the council and he was allowed to keep his tenancy. Being able to keep this young man in his home was the best feeling."

# IMPACT AT SCALE

By identifying the issues that affect the greatest number of people, our legal team has the opportunity to have a real impact. Pursuing one or two well-selected legal cases can transform the rights of generations to come.


## **ROSE'S FIGHT**

'No DSS' (Department for Social Security) lettings have, until recently, been commonplace with women and people with disabilities disproportionately affected. The 'No DSS' term is used in adverts when landlords or letting agents won't rent to someone on housing benefit.


Rosie, Amanda, and Emma all received housing benefit to help pay the rent. When each of them had to move – because of damp, domestic violence, and as their landlord was selling, respectively – they couldn't find a new home.

Rose, a Shelter Solicitor, helped Rosie prepare her case for court. It was settled with the letting agent admitting unlawful indirect discrimination on the basis of sex.

Successive cases saw wins for Amanda and Emma, and – following meetings with businesses including NatWest and Zoopla – 'No DSS' has since been removed from many mortgage terms and letting websites.

## STAND AGAINST INJUSTICE

We rely on generous individuals, trusts and corporates to drive our legal work to protect thousands of people from losing their homes.
