Introduction

Homelessness in England is at a record high and is continuing to rise. Across the country expensive, damp, crumbling homes are making people sick and holding them back. This is a result of us not building enough social homes for decades.

This report sets out the huge overall scale of homelessness in England in 2024 – and the areas where homelessness is most acute.

Homelessness can take many forms. This means that it is very challenging to accurately calculate the total number of people experiencing it. This report estimates the total number of people who are recorded as homeless on a given night in England in 2024. The types of homelessness included in this report are:

- People who have been accepted as homeless and now live in temporary accommodation arranged by their local council
- People who have been accepted as homeless and now live in temporary accommodation arranged by themselves or are living 'homeless at home' – meaning that they are legally homeless because it is not reasonable for them to continue to live in their home, but they are yet to be moved into temporary accommodation
- People who are sleeping on the streets (people sleeping rough)
- Single people who are homeless and living in hostel accommodation, but who are not counted amongst those in the statutory homelessness figures above
- People who are owed a duty under the Children's Act and are living in temporary accommodation that has been arranged by Social Services

We do not attempt to include the various forms of hidden or unofficial homelessness, such as sofa-surfing, or overcrowded households, and stick to what could be termed as 'recorded homelessness'. Wider definitions of homelessness would result in far more people being counted. Therefore, these figures are likely to be an underestimate of the true scale of homelessness. This report only covers England as homelessness laws, eligibility criteria and conventions on counting and recording differ between England, Scotland and Wales.

Tia's story

This report demonstrates the scale of the housing emergency that is currently raging in England. 354,000 is an astounding number, but each one is a person fighting for a home. Tia has shared her story to show the reality of homelessness behind these statistics.

Tia and her mum Natalie, were homeless from Tia's birth until she was four years old. They were put in touch with Shelter, and are now in a social home.

"Often we only had one bed, so I spent most of my childhood sharing a bed with mum. In fact, in one place, the room was so small we had to eat, sleep and play on the bed. I know my mum did everything she could to protect me. She tried her best to distract me from the terrifying world we were living in.

Now, I feel lucky to have my own bedroom, but I did find it really hard to get used to. I'd only ever shared a bed with Mum, so it took a long time to feel safe in my own bedroom. We used to have a little celebration whenever I managed to spend the whole night in my own bed.

Coming home from college now, it's like having a safety net – that's what home means to me. When we were living in temporary accommodation it was like a safety net full of massive holes that could break at any second.

Growing up homeless has definitely impacted me. I know that all Mum wanted for me was a normal childhood. With Shelter by our sides, we've finally got the foundation for life – a safe and secure home."

Methodology

The table below sets out how each component of the total is calculated, with the numbers relating to the reference number for each element used in the tables. Links to the sources used are below.

[1] Estimated number of people homeless and living in TA arranged by the council as of 30th June 2024

This is an estimate of the number of people (adults plus children) who live in households which have been found to be homeless and are living in local authority arranged temporary accommodation¹. The number of children is published in table TA1 of the Temporary Accommodation tables, from MHCLG's official statutory homelessness statistics.² The number of adults is calculated using the detailed household composition information in table TA2. Households categorised as 'other' household types are assumed to contain two people, in order to ensure that our estimate is conservative. Q2 2024 data is used wherever possible. If it is not available, the most recent available quarter is used. If no data has been published for a local authority in the previous 12 months, the area is excluded.

[2] Estimated number of people homeless and living in TA arranged by them or homeless at home as of 30th June 2024

This is an estimate of the number of people (adults plus children) who live in households who have been found to be homeless and are presently living in temporary accommodation arranged by themselves, or 'homeless at home'. 'Homeless at home' means that it is not reasonable for a household to continue to occupy their home, and they are therefore legally homeless. However, they have not yet been accommodated by the local authority. Data for households in these situations is found in the final columns ('Duty owed, no accommodation secured') of the TA1 tables in the official MHCLG statistics.³ Data is only published for the number of households and the number of these households who are families with children. In order to estimate the number of people in this situation, we have calculated the average size of a household in council arranged temporary accommodation in each region, and applied it to the figures for the number of households recorded as 'duty owed no accommodation secured'. These figures are submitted by councils to MHCLG, and are accurate to the best of our knowledge. Q2 2024 data is used wherever possible. If it is not available, the most recent available quarter is used. If no data was published in the previous 12 months, the area is excluded.

[3] Street homelessness

This is taken from MHCLG's homelessness statistics annual count of people sleeping rough, as at Autumn 2023 (most recent available).⁴ These figures are widely considered to be an underestimate of the true scale of street homelessness, especially for some marginalised groups, such as women, who may be less visible due to the risk of violence when sleeping rough.

[4] Additional single homeless people living in hostels

Some single people accommodated in temporary, homeless accommodation are not counted in the MHCLG statistics. To create an estimate of the number of additional single homeless people living in a hostel on any given night, we use hostel bedspace data from an annual Homeless Link report⁵

The research reports that the average void rate in this accommodation is 6%. Therefore, to get an estimate of how many people are staying in this accommodation on a given night, we remove 6% from the total number of bedspaces. In order to avoid any chance of double counting between these figures and those published by MHCLG, we then remove an estimate of the number of single person households who could have been already recorded in the MHCLG figures. To calculate this estimate, we use data in MHCLG table TA1 that gives the number of all households accommodated in different types of TA. We subtract the number of single households accommodated in the following types of temporary accommodation: 'hostels', 'local authority or housing association properties', 'private sector accommodation leased by a council or run by a registered provider' and 'other TA including supported lodgings' in the statutory temporary accommodation figures (all categories in which beds reported in the Homeless Link figures could fall theoretically.) We report on this at the national level only, as the adjusted regional figures are not individually reliable enough to report on.

[5] Social services accommodation

The number of people (adults and children) living in temporary accommodation arranged by Social Services under section 17 of the Children's Act is estimated based on data collected by Freedom of Information request (Fol). We sent an Fol to all county and unitary authorities in England, asking what this figure was as of 30th June 2024 or the nearest available date. We received full responses from 83 (53%) local authorities and partial responses from a further 10 (6%) councils. Not all councils hold or are able to access this data. We simply report on the numbers supplied. Data and knowledge on these households is scant, so no extrapolation or averaging up is done, meaning that this figure is very likely an underestimate. We report this at a national level only.

[6] Estimated total number of homeless children

This is the estimated total number of children who are homeless. This number is a subset of those counted under [7]. At the national level it sums up the number of children living in temporary accommodation arranged by the local authority under homelessness legislation and the number of

children living in temporary accommodation arranged by Social Services under Section 17 of the Children's Act. At regional and local level it is just the number of children living in temporary accommodation arranged by the local authority.

[7] Estimated total number of homeless people

This is the estimated total number of people (adults and children) who are homeless. At the national level it sums elements [1] – [5] above, at regional and local level it sums elements [1] – [3].

[8] Rate of homelessness

This is the rate of people who are homeless in a given area, calculated by comparing the estimated number of people who are homeless in that area to the area's total population, using the latest available ONS census statistics⁶

N.B. Estimates based on official statistics published by MHCLG are used for all the levels of analysis in this report – national (England), regional and local. Data on people accommodated by social services are based on responses to Fols. Data on other single homeless people (outside of statutory provision) is based on a database of housing providers and adjusted. This means they have a wider margin of error, and so are not shown at regional or local levels. Local authorities have been removed from the analysis where data is unavailable.

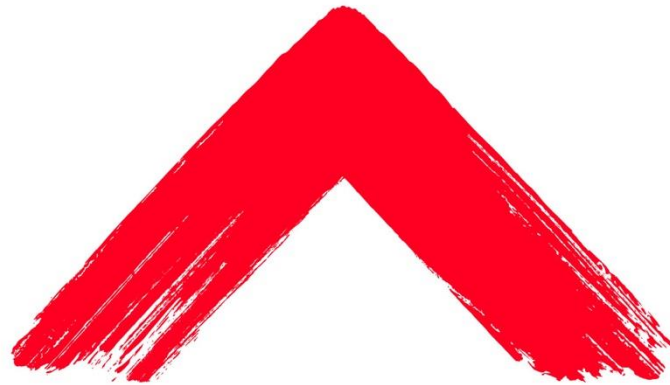
