

## Aviation Gin Father's Day Sweepstakes Official Rules

**5. Winner Notification:**

The winner will be notified by e-mail and/or phone from Administrator on or about June 17<sup>th</sup>, 2025 (method[s] of notification is of Sponsor's sole determination).
