

## **Uncertainties?**

With everything that's happening in the world today it's obvious that we live in uncertain, unsettled times, and Carriden Church, having opted for Dissolution, also faces uncertain times.

As far as the buildings are concerned one example of this uncertainty is that over the past few months I've heard "confirmed" news that when Carriden Parish Church finally closes it will be sold to Cuthill's Funeral Directors, sold for redevelopment or sold to be turned into flats.

No one knows what will happen to the church building. The bottom line is that, when Carriden unfortunately closes its doors for the last time, the General Trustees of the Church of Scotland will decide what happens to the Church building.

However what happens to the buildings is only one part of the Dissolution process. So, as I write this on the 24<sup>th</sup> June, what is happening?

Presbytery of Forth Valley and Clydesdale have now confirmed that their Mission Plan Action Group is calling Kirk Session meetings at 2pm on Wednesday 19th July and Monday 31st July.

The first meeting with the Kirk Session will discuss the Basis of Dissolution, much of which is legally proscribed, at which the Kirk Session can make their views known regarding what happens to the Church funds and may also discuss the date when the church closes.

The second meeting with the Kirk Session is when they take a formal vote, agreeing the draft Basis of Dissolution, which is to be presented to the congregation allowing members and adherents to vote for or against the basis of dissolution.

A Congregational meeting to vote on the Basis of Dissolution is likely to be called at 7.00pm on Monday 14<sup>th</sup> August.

So when facing changing circumstances ....our challenge when facing uncertainty is to keep faith in God who has faith in you.

You may not see the way ahead in your Christian life, but I would bring to you Jesus words of comfort and assurance, recorded in Matthew's gospel, Ch28:18-20, which he gave in his great commission to his disciples, "All authority in heaven and on earth has been given to me. Therefore go and make disciples of all nations, baptising them in the name of the Father and of the Son and of the Holy Spirit, and teaching them to obey everything I have commanded you. And surely I am with you always, to the very end of the age"

Jesus words, "I am with you always, to the very end of the age", bring us Certainty in an age of uncertainty. They bring us direction in an age of doubt. They bring us the certainty of a future, which is different, but which remains rooted in the love God has for you.

May God give you peace.
