- Parents / legal guardians of children between the ages of 16 and 18 years (the mature minor) are required to sign this form providing permission to treat their child in the Endeavour Wellness Clinic without the parent / guardian's attendance.
- Any mature minor attending a clinic without this form on file will not be permitted to enter the clinic session.

Important notes when signing this form:

For the purposes of the operations of the Endeavour Wellness Clinic, a "mature minor" is deemed to be any person between 16 and 18 years of age. A mature minor can only attend the clinic unaccompanied with the written permission of their parent or legal guardian on this form.

If a parent or legal guardian does happen to accompany a mature minor during their consultation, the mature minor has the right to ask the parent or legal guardian to wait outside the consultation room for any or all of the consultation if this form has been signed.

In instances where the parent or legal guardian refuses to leave the consultation room, the consultation will be suspended and a referral to an external practitioner will be arranged (e.g. a referral to a fully qualified complementary or western medical health practitioner).

For the purposes of the Endeavour Wellness Clinic, a "minor" is deemed to be any person who is under the age of 16 years of age - and they must be accompanied at all times by an adult or legal guardian (i.e. both during the actual consultation and/or whilst visiting the clinic). It is not permissible for a parent or legal guardian to leave the consultation room at any time during a minor's consultation.

Should the situation arise where a minor requests that their parent or legal guardian leave the consultation room, the consultation will be suspended and a referral to an external practitioner will be made (e.g. a fully qualified complementary or western medical health practitioner).

All treatments involve the taking of a thorough case history, which may involve questions and discussions of a personal nature. It is also common practice for a comprehensive physical examination to take place as part of a consultation and it may therefore be necessary for the client to disrobe or partially disrobe as part of the treatment (this is especially true for massage and Acupuncture consultations, but may be necessary for other disciplines as well).

In any event, a gown and/or towels will provided to ensure modesty at all times.

For most consultations there is normally a minimum of two student practitioners present in the treatment room. However for Myotherapy, Relaxation Massage, Remedial Massage and Tui Na Massage, treatment is undertaken by a sole student practitioner.

Please note that a Clinic Supervisor also approves any treatment given by a student practitioner prior to them initiating actual treatment.

All clients receiving treatment at Endeavour Wellness Clinic have the right to privacy and confidentiality with regards to any discussions taking place as part of their treatment and/or recorded within their client file, and a mature minor will be extended these same rights.
