Additional Information

Aboriginal and Torres Strait Islander people

- Endeavour College of Natural Health offers scholarships for students of Aboriginal and Torres Strait Islander descent (full-time study only):
 - Aboriginal and Torres Strait Islander Commencement Scholarship This scholarship is for full-time students of Aboriginal and Torres Strait Islander descent who are commencing in year one of any Bachelor of Health Science degree. The recipients of this Scholarship will be awarded a payment of \$1,500 after the census date of their first semester of full-time study has passed, to assist with the general costs associated with commencing higher education study.
 - Aboriginal and Torres Strait Islander Commencement Textbook Pack This scholarship is for full-time students of Aboriginal and Torres Strait Islander descent who are commencing in the Diploma of Health Science. The recipients of this Scholarship will be awarded a reimbursement of the cost of their first semester textbook pack after the census date of their first semester of full-time study has passed, to the value of \$660.

Other Domestic student scholarships

- Endeavour College of Natural Health offers other scholarships for domestic students looking to enter fulltime study:
 - Full-time Study Scholarship This scholarship is for new full-time students who are commencing in either the Bachelor of Health Science (Naturopathy) or the Bachelor of Health Science (Nutritional and Dietetic Medicine) degree. This includes all commencing full-time students including those graduating from the Diploma of Health Science and upgrading to the degree. The recipients of this Scholarship will be awarded tuition support (financial) of four credit points worth of study each semester for the duration of the course. This could equate to up to 25% of the course tuition fees. Note: recipients must maintain a pass grade, scholarship is applied to the first attempt of a subject only, and if the student moves to a study load less than 100% the scholarship will conclude.
 - Academic Achievers School Leavers Scholarship This scholarship is for full-time domestic students who have graduated high school in the past three (3) years and who are commencing in the Diploma of Health Science. The recipients of this Scholarship will be awarded tuition support (financial) of four credit points worth of study each semester for the duration of the course (up to a total of eight credit points of tuition support).

Domestic applicants with overseas qualifications

Applicants seeking admission based on undergraduate qualifications from overseas must provide evidence that the undergraduate qualification achieved is equivalent to the relevant Australian qualification requirements for admission.
