



Credit Union 1 General Giveaway Rules for Social Media

By entering this giveaway, participant agrees to abide by the following terms and conditions. You must have internet access in order to participate. Void where prohibited.

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.**
2. **Sponsor.** CUI Social Media Giveaways are sponsored by Credit Union 1 ("Sponsors"), 1941 Abbott Rd, Anchorage AK 99507.
3. **Prize.** The number of prizes and description of prize will be clearly listed on the giveaway social media post for each giveaway promoted by the Sponsor. Prizes are not negotiable and cannot be exchanged for cash value.
4. **Entry Period.** The entry period for the giveaway will be clearly listed on the giveaway social media post for each giveaway promoted by the Sponsor.
5. **Eligibility.** Must be a legal Alaska and US resident, 18 years of age or older. Employees of Credit Union 1 and their immediate family members and/or those living in the same household of each are not eligible to participate. Void where prohibited by law.
6. **Odds of Winning.** Odds of winning each prize will be based on the number of eligible entries received.
7. **Winner Selection.** Winner will either be selected by a random generator or by most likes from all eligible entries, as specified in the post. If there is a tie, then out of the tied participants, a winner will be randomly selected
8. **Winner Notification.** Winner will be notified via the social media outlet in which they entered. If a potential winner does not respond within forty-eight (48) hours of the first notification attempt, the potential winner will forfeit his or her prize and an alternate winner may be selected based on the Sponsors discretion.
