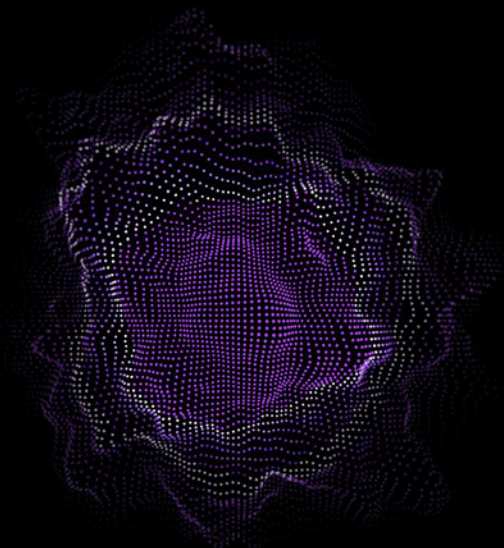

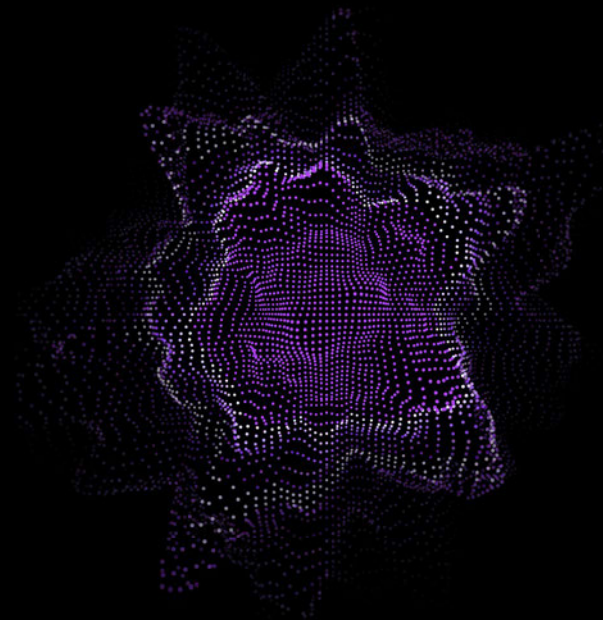


HOW IT WORKS

- Location: Physical — in Australia across three cities: Melbourne, Sydney and Brisbane; and virtual for remote and international participation

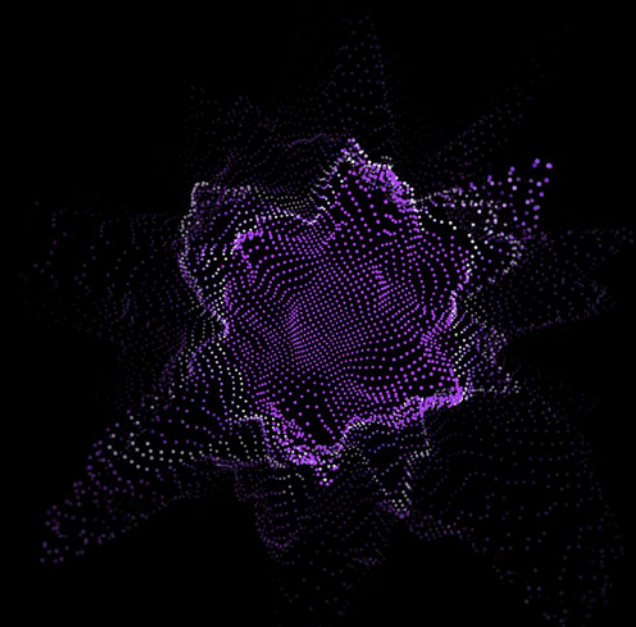


PROGRAM OVERVIEW

The ESG and Climate Tech program focuses on solutions centred primarily on:

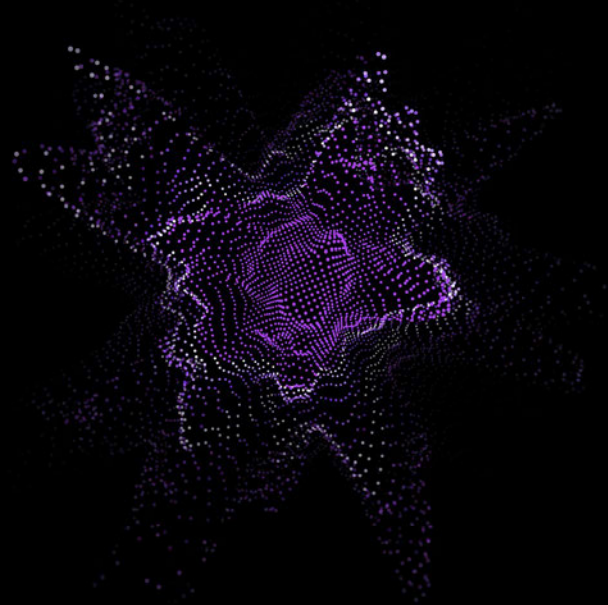
- Measuring and monitoring environmental impact

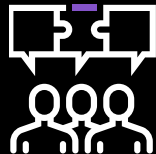
The LawTech Hub program offers opportunities for collaboration; access to mentors, legal tech entrepreneurs and other residents; continuing alumni support and more.

Access coaching from mentors and advice from industry experts and program alumni with real-time feedback from clients, lawyers and technical teams.



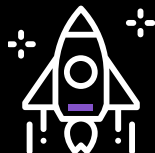

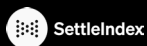

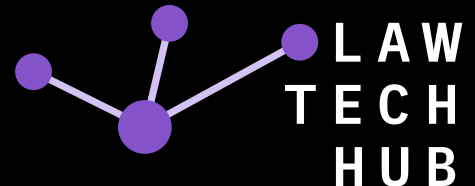
