2024 AMERICAN DREAM “SPIN TO WIN SWEEPSTAKES 1”
OFFICIAL RULES**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT WILL NOT INCREASE OR IMPROVE YOUR CHANCES OF WINNING.

1. ELIGIBILITY: The 2024 American Dream “Spin to Win Sweepstakes 1” (the “Sweepstakes”) is only open to entrants who, as of the entry date, are permanent legal residents of the United States or the District of Columbia, excluding Michigan, Ohio, and Virginia, who are at least eighteen (18) years old at the time of entry (residents of Alabama and Nebraska must be 19 years of age, residents of Mississippi must be 21 years of age). Residents of Michigan, Ohio, and Virginia are not eligible to participate in the Sweepstakes. The Sweepstakes is void outside the eligible Sweepstakes territory; and where prohibited or restricted by law. Employees, officers and directors of Ameream LLC d/b/a American Dream (“Sponsor”) and its respective parents, subsidiaries, affiliates, divisions, advertising and promotion agencies, and the immediate families (defined as parents, spouses, children, siblings, grandparents, and their respective spouses) or members of the same household (whether related or not) of each such employee, officer and director, are not eligible to enter.

2. TIMING: The “Sweepstakes Entry Period” begins on November 29, 2024 at 8 AM Eastern Standard Time (“EST”) and ends on November 29, 2024 at 8:59 AM EST (the “Entry Submission Deadline”). Entries received after the Entry Submission Deadline or outside the Sweepstakes Entry Period are void. **All entries must be received by Sponsor(s) on or before Entry Submission Deadline** as determined by Sponsor’s clock.

3. HOW TO ENTER: Eligible individuals may enter the Sweepstakes once during the Sweepstakes Entry Period by visiting <http://www.americandream.com/shop-spin-win> (the “Website”) and following the links and instructions for the Sweepstakes and spinning the “Wheel of Wins” in person at the “Spin To Win!” event at American Dream. By completing the entry form in accordance with the instructions on the Website, you represent that you have complied with the submission guidelines and content restrictions as specified on the Website.

4. LIMIT: Entries are limited to one per person per email address. All entries will be deemed to have been made by the authorized account holder for the submitted email address. Each entrant will get one (1) spin on the “Wheel of Wins”. Entrants may be subject to verification prior to being able to spin the wheel. Eligibility, age and other claims of/information provided by a potential prize winner are subject to verification by Sponsor or a prize supplier. Entrants will cooperate with Sponsor, a prize supplier, or their respective representatives in connection with any and all verification activities, including, without limitation, by executing and delivering to Sponsor, a prize supplier or their respective designees by the time indicated by Sponsor, prize supplier or their respective designees any authorization forms required by Sponsor, a prize supplier or their respective designees.

5. AGREEMENT TO OFFICIAL RULES AND DECISIONS: By participating in the Sweepstakes, each entrant fully and unconditionally agrees to be bound by and accepts these Official Rules and the decisions of Sponsor (including, without limitation, decisions regarding eligibility of entries and entrants, the selection of entrants and winner, and the awarding and redemption of prizes), which are final and binding in all respects.

6. SWEEPSTAKES PARTICIPATION AND PRIZE REDEMPTION: Each potential Prize winner will be notified in person at the “Spin To Win!” event. The odds of which specific prize is won will vary based upon the total combined number of eligible entries received. Eligible individuals may only win one time during the entire “Spin To Win! Sweepstakes 1” Period.

All prizes are subject to the terms and conditions of these Official Rules and any other terms and conditions imposed by the prize supplier. Entrants must comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. Each potential Prize winner shall be required by Sponsor to execute and return to Sponsor, within three (3) days of the date notice or attempted notice is sent, an Affidavit of Eligibility, a Liability Release, and, except where prohibited by law, a Publicity Release (an “Affidavit/Release”) in the form provided by Sponsor in order to redeem and claim the potential winner’s Prize. If a potential winner fails to return the required Affidavit/Release within the specified time, or if a potential winner is found to be ineligible, or if the potential winner does not comply with the Official Rules (including, without limitation, by not timely redeeming the Prize within the required time period), then such potential winner may be disqualified and will forfeit the Prize

unless an eligible person is randomly selected by Sponsor as the winner. The eligible person shall be required to execute and return to Sponsor an Affidavit/Release. Sponsor, reserves the right (but has no obligation) to award such prize to any individual in such manner as determined by Sponsor in its sole discretion.

If applicable, a winner will be issued an IRS Form 1099 for the actual retail value of the prize. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of this Sweepstakes is a violation of criminal and civil laws, and, should such an attempt be made, Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision or any other provision of these Official Rules.
