## American Dream Spring Break Sweepstakes

## Official Rules

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: Only legal residents of the 50 United States and the District of Columbia who are 18 years of age or older at the time of entry (residents of Alabama, and Nebraska must be 19 years of age, residents of Mississippi must be 21 years of age) are eligible to enter the American Dream Spring Break Sweepstakes ("Sweepstakes"). - **3. Sweepstakes Period:** The Sweepstakes Period begins on February 17, 2023 at 10:00AM Eastern Standard Time ("EST") and ends on March 9, 2023 at 11:59PM EST (the "Entry Submission Deadline"). Entries received after the Entry Submission Deadline or outside the Sweepstakes Period are void. **All entries must be received by Sponsor(s) on or before Entry Submission Deadline** as determined by Sponsor'(s) clock.
