

COLLEAGUE VEHICLE DISCOUNT PROGRAM



The GM Supplier Discount Program allows eligible colleagues to receive discounts on GM vehicles. To learn more about the program, call Program Headquarters at **1-800-960-3375** or visit www.gmsupplierdiscount.com. The CVS Health company code is 803932.



With Chrysler's Affiliate Rewards Program, you are eligible to receive the Preferred Price (1% below factory invoice) on the purchase or lease of most new Chrysler, Jeep, Dodge Ram, and FIAT vehicles. First, you need to create an account at www.FCAUSAffiliates.com using your Company Code. Once you're logged in, click the "Get Control Number" button at the top of your home page and to create your Control Number, which you'll also receive via email.

Then, take your Control Number with proof of eligibility—a company photo ID, W-2 form or recent paycheck stub—to a participating local dealership and request the Affiliate Rewards Preferred Price. You can ask to see the vehicle invoice, where the Preferred Price ("PP") is listed. A \$75 administration fee is already included in the Preferred Price on the invoice.
