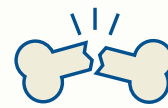

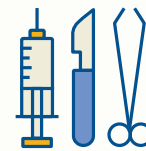

# Group Pet Insurance

Coverage includes: emergency treatments, surgeries, medications, laboratory services, optional wellness, and more. Plus, you can visit any licensed veterinarian or specialist in the US or its territories.

## Choose between Accident & Illness and Accident & Illness + Wellness coverage:

All pets must be enrolled in the same plan.

- **Accident & Illness** – Covers injuries that result from accidents, such as bee stings, animal bites, foreign ingestion and broken bones. Also includes coverage for illnesses and more serious medical conditions a pet can develop at any point in their life, such as ear infections, allergies, heart conditions, diabetes or cancer.
- **Accident & Illness + Wellness** – Considered “head to tail” coverage. In addition to accidents and illnesses, this plan includes coverage for routine care such as vaccinations, parasite prevention, spay/neuter and annual wellness exams.

- You can change your plan option **only** during the annual renewal change period: September 1–15 for coverage effective October 1.
- During the policy year, you can add newly adopted pets within 31 days of adding them to your family. You can remove pets or cancel your policy at any time.
