Acceptance and Duration

- Information on how to enter and the Prize form part of these Conditions of Entry and the Schedule.
- By entering, each entrant agrees that they have read and accepted these Conditions of Entry and the Schedule. Capitalised terms have the meaning given in the Schedule unless otherwise stated.
- The Promotion commences on the Start Date and ends on the End Date. Valid and eligible entries will be accepted only during the Promotional Period.

Eligibility to Enter

- Entry is open only to Australian residents who are 18 years and over who satisfy the membership and entry requirements in the Schedule.
- An entrant must be an individual and not a company or organisation. Employees and immediate family members of the Promoter, participating venues, agencies and businesses directly associated with the Promotion or winner determination are ineligible.
- The time of entry is the time the qualifying item is added to the entrant's Wishlist. Subject to applicable law, the Promoter's records are final as to receipt time.
- The Promoter accepts no responsibility for late, lost or misdirected entries caused by technical disruption, network congestion or another cause beyond its reasonable control.

Redeeming Prize
