

OFFICIAL RULES  
Win a Peloton Bike+ Prize Draw (“the Promotion”)

**NO PURCHASE NECESSARY TO ENTER OR WIN.**

**ELIGIBILITY:** OPEN ONLY TO LEGAL RESIDENTS OF AUSTRALIA, WHO ARE AT LEAST 18 YEARS OF AGE. VOID WHERE PROHIBITED. Employees (and their immediate families (spouse, and parents, children and siblings and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related) of Peloton Interactive Australia Pty Ltd (ABN 37 644 958 047) (“Sponsor”), its parent, affiliates, subsidiaries and advertising and promotion agencies are not eligible to enter or win. If such documents are not returned (via email is fine) within the specified time period, a prize or prize notification is returned as undeliverable, or a potential winner is not in compliance with these rules, prize will be forfeited and, three months after the drawing took place, an alternate winner selected using the same draw process. To the extent necessary for Sponsor to comply with any legal requirements, Sponsor will liaise with any applicable regulators before doing so.
