

LIST OF PROHIBITED ITEMS

Passengers may not have the following items with them in security restricted areas or on board aircraft:

Firearms and guns

Any items that could be used to fire a projectile or inflict injury, or create the impression of being possible to use for this purpose:

- All types of firearm, such as pistols, revolvers, rifles and hunting rifles
- Toy rifles, replica and imitation rifles that could be mistaken for real weapons
- Firearm components, with the exception of telescopic sights
- Air rifles and CO² air rifles, such as pistols, shotguns, rifles and BB guns
- Alarm pistols and starting pistols
- Bows, crossbows and arrows
- Harpoon guns and spear guns
- Catapults
- Etc.

Stunning devices

Passengers may not take devices that are specifically designed to stun or immobilise onto aircraft:

- Devices that could be used to administer shocks, such as stun guns, laser weapons and cattle prods
- Devices used to stun and kill animals
- Chemical substances, gases and sprays, such as mace, pepper spray, tear gas, acid spray and sprays used to repel animals, that could be used to disable or incapacitate people
- Etc.

Sharp, pointed objects:

Objects with sharp points or edges that could be used to inflict serious injury:

- Ice axes and ice picks
- Shaving blades
- Credit card knives
- Cutter knives
- Knives with blades longer than 6 cm
- Scissors with blades longer than 6 cm, measured from the pivot point
- Combat-sport items with sharp points or edges
- Swords and sables
- Crowbars
- Drills and drill chucks, such as portable, cordless electric drills
- Tools with blades or shafts longer than 6 cm that could be used as weapons, such as portable, cordless electric saws
- Saws, such as portable, cordless electric saws
- Soldering irons
- Captive bolt guns and nail guns
- Etc.

Blunt objects

Blunt objects that could be used to hit and, by doing this, cause

serious injury:

- Baseball and softball bats
- Clubs and sticks, such as wooden sticks, batons and truncheons
- Combat-sport objects
- Etc.

Explosives and flammable substances and devices

Substances and devices that could be used to inflict serious injury or endanger the safety of the aircraft, or that give the impression they could be used for this purpose:

- Ammunition, detonators, detonators and fuses
- Replicas and imitations of explosive objects
- Mines, grenades and other (military) explosives
- Fireworks and other pyrotechnic materials
- Smoke cans and patterns
- Dynamite, gunpowder and plastic explosives
- Etc.

Chemical and toxic substances

- Acids and alkalis, such as 'wet' batteries.
- Corrosive and bleaching agents, such as chlorine and mercury
- Poison
- Infectious and hazardous biological material, such as infected blood, bacteria and viruses
- Materials that could spontaneously ignite or combust
- Fire extinguishers
- Etc.

Passengers may not have the following items in their hold luggage:

- Explosives, such as detonators, fuses, mines, grenades and detonating substances
- Flammable and combustible liquids and substances, such as petrol, methanol, magnesium and firelighters
- Gases, such as propane and butane
- Toxic and infectious substances, such as arsenic and infected blood
- Radioactive material, such as medical and commercial isotopes
- Corrosive material, such as mercury and vehicle batteries
- Parts of (vehicle) fuel systems that have contained fuel
- Fireworks and signal fireworks
- Ammunition, detonators, smoke cans and patterns
- Materials that could spontaneously ignite or combust
- Etc.

This list is not exhaustive. A security employee could refuse an item for security reasons.

Additional airline rules

An airline may impose additional rules about what you may or may not take onto an aircraft. Always check which items your airline will not allow you to take on board in your hand and/or hold luggage.

These items will often include lithium batteries or devices that are powered by lithium batteries. For example:

- Hoverboards
- Airboards
- Oxboards
- E-skates
- Waveboards
- U-runners
- Battery-powered suitcases
- Damaged, faulty and withdrawn portable electronic devices
- Electronic cigarettes - often only in hand luggage
