Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

Giveaway may only be entered in or from the 50 United States and the District of Columbia and entries originating from any other jurisdiction are not eligible for entry. This Giveaway is governed exclusively by the laws of the United States. You are not authorized to participate in the Giveaway if you are not located within the 50 United States or the District of Columbia.

1. How to Enter. During the Giveaway Period, visit the online entry form made available through the Bob Evans Loves Nanas Sweepstakes signage (including in-restaurant table tents), Sponsor's owned channels, or paid social media, and complete and submit the online entry form.
