(“**Uni-Select**”) rewards programs (“**Programs**”) are intended solely for purchases made through authorized Automotive Service Providers (Automotive Service Provider defined as Uni-Select’s client using Bumper to Bumper Auto-Service or Uni-Pro Trademarks based on a valid licence agreement signed with Uni-Select. Enrollment in the Program must receive written prior approval from Uni-Select. Employees of Uni-Select, its subsidiaries, and affiliates are not eligible to participate or earn rewards in these programs. Purchaser is responsible for all applicable taxes and other fees.

**Personal Information:** Participants are required to provide certain personal information in order to receive reward payments and for communication purposes. Participants’ personal information will only be used for such payment and claim communication purposes and will not be used for any other purpose. If you do not wish to provide such information, please do not participate.

**Qualifying Purchases:** Purchases made between August 1st, 2021 and September 30th, 2021 are eligible for rebate. Claims must be submitted by October 31st, 2021. Purchase must occur alongside service at an eligible auto service location. Consumers may qualify for one reward per invoice. In addition to these terms and conditions, each separate Program has terms and conditions to determine sales eligible for rewards. Participants may claim only qualifying purchases of Uni-Select products. Use your Visa prepaid card anywhere Visa cards are accepted worldwide. Card is issued by Peoples Trust Company pursuant to a licence from Visa Int. \*Trademark of Visa International Service Association and used under licence by Peoples Trust Company. Your use of the prepaid card is governed by the Cardholder Agreement, and some fees may apply. This is not a gift card. Please note that prepaid cards are subject to expiration, so pay close attention to the expiration date of the card.

In the event of Program termination, Program participants will have 30 days from the Program termination date in which to submit final reward claims.
