

# Jägermeister Tap 30 Sweepstakes

## Official Rules

**NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE DOES NOT IMPROVE CHANCES OF WINNING. **Sweepstakes Name:** Jägermeister Tap 30 Sweepstakes (the “Sweepstakes”).

**Sweepstakes Dates:**

- **Sweepstakes Registration Period** is scheduled to begin at 12:00:00am Eastern Time (“ET”) on 10/25/2023 and end at 11:59:59pm ET on 11/15/2023 (the “Registration Period”). The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void outside of the fifty (50) United States and District of Columbia, and wherever prohibited or restricted by law.

**Who may Enter:** Sweepstakes is open only to legal residents of the fifty (50) United States and District of Columbia, who are age twenty-one (21) years of age or older as of date of entry, and have a valid U.S. driver’s license or government-issued photo ID (“Entrant”), except the following persons who are not eligible to enter or win:

**How to Enter:** Access the Instagram application on your compatible mobile device. Entrants must (a) follow the Jägermeister Instagram handle (@JagermeisterUSA) and (b) must be an active holder of a non-private Instagram account (holders with private account settings may not enter in this method). If you do not have the Instagram application, you may download it through the application store on your mobile device. The Instagram application is free, and Instagram’s Terms of Use apply. For details, visit <http://instagram.com/legal/terms/>. After completing steps (a) and (b) above, (c) visit <https://www.jagermeister.com/en-US/tap30sale> during the Registration Period. Follow the online entry instructions provided to be entered into the grand prize drawing. Each entrant must fully complete the online registration page with all required information including his/her name, valid email address ZIP code and Instagram handle. After having read and agreed to these Official Rules, click the submit button to submit your online entry and to earn one (1) entry in the Sweepstakes (“Online Entry”). All online entries must be fully complete for all required information, and must be received by 11:59:59 pm ET on **11/15/2023** to be eligible. If you enter on a wireless service provider’s network (as opposed to a WiFi network), your carrier’s text and data rates will apply. You should consult your wireless service provider’s pricing plan for details. You agree to incur any and all charges imposed by your wireless carrier.

- **Additional Entry:** Entrants who complete the Online Entry will have an opportunity to earn one (1) additional entry in the Sweepstakes by completing a survey (“Survey”) at <https://www.jagermeister.com/en-US/speak-up>. Survey may be completed prior to or after submitting an Online Entry. Entrants will be required to complete all required information and answer six (6) Survey questions to complete the Survey, and must be submitted by 11:59:59 pm ET on **11/15/2023** to be eligible. Upon completion of the Survey, each entrant will receive one (1) Entry in the Sweepstakes (“Survey Entry”).

Online Entries and Survey Entries are collectively, “Sweepstakes Entries” and individually, a “Sweepstakes Entry.” Eligible participants having submitted a Sweepstakes Entry are individually referred to as an “Entrant” and collectively, “Entrants.”

**By participating and submitting an Entry, Entrants agree that Sponsor and its designated parties are authorized to contact Entrant via email, mail, phone, or any other form of media to make contestant aware of information pertinent to the Sweepstakes, and to distribute information regarding the Sponsor's featured products, special events or future contests, promotions, or offers. **Winner Selection and Notification:** At the conclusion of the Registration Period, a random drawing shall be conducted by the Sweepstakes Administrator from among all eligible Entries received to select one (1) potential grand prize winner and two (2) potential second prize winners ("Potential Winners"). Potential Winners will be notified initially by phone, email or Instagram Direct Message. If the Administrator is unsuccessful in its attempt to reach and speak directly with a Potential Winner after 48-hours, then that Entrant may be disqualified and an alternate Potential Winner may be determined from the remaining Entries per the procedures outlined above. **Note: messages may or may not be left during the Potential Winner notification process.**
