

LP® Project Panel 90-Day Limited Warranty

The provisions and terms of this 90-day Limited Warranty apply to LP® Project Panel (the “Product”) manufactured by Louisiana-Pacific Corporation (“LP”) and sold exclusively by Lowe’s. The Limited Warranty is made to the original retail purchaser of the Product (the “Owner”) and cannot be assigned, sold, or transferred to any other person.

In the event the Product experiences (i) delamination (separation between the strands of the OSB that normally are properly compressed in the pressing operation), splitting, or core voids, (ii) caused by a manufacturing defect in the Product (iii) resulting in a reduction of structural strength that prevents the Product from performing as a small project panel, or any failure to conform to any implied warranty not effectively disclaimed herein, for a period of ninety (90) days from the date of retail purchase of the Product, LP will refund the original purchase price of the affected Product. NOTE: conditions such as loose or folded surface flakes, minor edge swelling, or edge checking that do not reduce the Product’s strength do not qualify for the remedy set forth above.

The Product is subjected after sale to wear and tear and various conditions outside of LP’s control. As such, **this is the Owner’s sole and exclusive remedy for any non-conformance of or alleged defect in the**

Product or any damage caused by the Product. In no event will LP be liable for any incidental, special, multiple, punitive, indirect, consequential, or resulting damages, including, without limitation, damage to any property, lost work, re-work, lost profits, labor costs, or any other costs. LP disclaims all other warranties, express or implied, including implied warranties of merchantability or fitness for a particular purpose, and any warranties arising from course of dealing or advertising. Where warranties arise under consumer product warranty laws and cannot be lawfully disclaimed, such warranties are limited to the shortest period permitted or required under applicable law.

To make a warranty claim, owner must contact LP (see below) within the 90-day warranty period and provide proof of purchase of the Product.

This Limited Warranty applies where the date of retail purchase of the Product is on or after 08/01/2025.

The Product is not intended to be used as siding on residential or accessory structures governed by building codes and does not meet the dimensional requirements of Department of Commerce Voluntary Product Standard PS2.
