## LP® SmartSide®, LP® SmartSide® ExpertFinish® and LP BuilderSeries® 90-day Limited Warranty for Interior Use

The provisions and terms of this 90-day Limited Warranty apply to LP® SmartSide® Trim & Siding products (including ExpertFinish®) and LP BuilderSeries® Lap Siding (the “Product”) manufactured and sold by Louisiana-Pacific Corporation (“LP”). The Limited Warranty is made to the original retail purchaser of the Product (the “Owner”) and cannot be assigned, sold, or transferred to any other person.

In the event the Product, when used in an interior application, manifests a manufacturing defect that makes the Product unfit for interior use, or fails to conform to any implied warranty not effectively disclaimed herein, for a period of ninety (90) days from the date of installation, provided that the Product is transported, stored, handled, installed, finished, maintained, and used in strict accordance with the applicable portions of the relevant Product’s Application Instructions, and the claim is not otherwise excluded, LP will, at its option, either replace or refund the purchase price of the affected Product.

The Product, which is designed and sold primarily for exterior use, is subjected to wear and tear and various conditions outside of LP’s control when used in an interior application. As such, this is the sole and exclusive remedy available to the owner of the Product used in an interior application. **In no event will LP be liable for any incidental, special, multiple, punitive, indirect, consequential, or resulting damages, including, without limitation, damage to any property, lost work, re-work, lost profits, labor costs, or any other costs. LP disclaims all other warranties, express or implied, including implied warranties of merchantability or fitness for a particular purpose, and any warranties arising from course of dealing or advertising.** Where

warranties arise under consumer product warranty laws and cannot be lawfully disclaimed, such warranties are limited to the shortest period as permitted or required under applicable law.

To make a warranty claim, owner must contact LP (see below) within the 90-day warranty period and provide proof of purchase of the Product.
