VARIMAX SYSTEMS SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. VOID WHERE PROHIBITED BY LAW.

- 1. **Sweepstakes Entry Period**. The "Sweepstakes Entry Period" begins at 12:00:01 A.M. Central on March 14, 2023 and ends at 11:59:59 P.M. Central on May 26, 2023.
- 2. **Eligibility**. The Varimax Systems Sweepstakes ("Sweepstakes") is open only to farmers who make their primary income from farming, who are: (a) legal U.S. residents, and the District of Columbia (excluding Rhode Island, New York and Florida), (b) 21 years of age, and (c) have at least two fields.
