Sweepstake Rules

EARTHOPTICS AND FORGROUND SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. VOID WHERE PROHIBITED BY LAW.

- 1. **Sweepstakes Entry Period**. The "Sweepstakes Entry Period" begins at 12:00:01 A.M. Central on February 7, 2023 and ends at 11:59:59 P.M. Central on March 8, 2023.
- 2. **Eligibility**. The EarthOptics and ForGround Sweepstakes ("Sweepstakes") is open only to farmers who make their primary income from farming, who are legal U.S. residents, and the District of Columbia (excluding Rhode Island, New York and Florida) who are at least 21 years of age. Void in Rhode Island, New York, Florida, Puerto Rico, the U.S. Virgin Islands, U.S. military installations in foreign countries and where prohibited or restricted by law.
