

Full terms and conditions

- 1 Information regarding prizes and how to enter forms part of these conditions. By entering, entrants accept these conditions. Nothing in these conditions restricts, excludes or modifies or purports to restrict, exclude or modify any statutory consumer rights under any applicable law including the *Competition and Consumer Act 2010* (Cth).
- 2 Entry is open only to Australian residents aged 18 years or older. Directors, management and employees of the Promoter and associated companies and agencies as well as the immediate families of each of these people are not eligible to enter.
- 3 The promotion begins on 12.01 am Sydney time, 1st of June, 2026 and closes 11.59pm Sydney time, 10th of July, 2026 (**Promotion Period**).
