Additional Details:

Description of the Planned Network Change(s):

The switches identified in Column A of Attachment A (“OH Decommissioned Switches”) will be retired and removed from Uniti’s network as a result of network modernization and consolidation after all traffic served by these switches is migrated to the associated Target Switch(es) in Column E of Attachment A (“Targeted Switches and A-Blocks Moves”). All A-Blocks are being moved to the associated Target Switch(es) in Column E of Attachment A (“Targeted Switches and A-Blocks Moves”). All traffic to be migrated includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), wireless and paging traffic.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups builds for the OH Decommissioned Switches or have existing trunk groups to the switches augmented. Carriers that are code holders for OH Decommissioned Switches will be required to reposition the codes to the associated Targeted Switches and A-Blocks.

All ASRs for Targeted Switches and A-Blocks must be received no later than June 10, 2026, in order to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the OH Decommissioned Switches prior to their eventual decommissioning.

Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the OH Decommissioned Switches (on or after June 11, 2026). This will serve to guide interconnect re-routes of Uniti traffic for native codes currently served by the OH Decommissioned Switches to reflect the associated switch in the Targeted Switches and A-Blocks as the new home switch. All ASRs for the Targeted Switches and A-Blocks must carry the project code identified in Column F of Attachment A.
