Description of the Planned Network Change(s):

The DMS10 switch, located at 104 S Main St, Sheffield PA 16347, will be decommissioned, powered down, and removed from Windstream's network as a result of network modernization and consolidation. All traffic will need to be routed to the SHFDPAXSPS0 Meta Switch, located at 104 S Main St, Sheffield PA 16347.

Windstream SHFDPAXSDS0 A-Block of 814-968 is being moved to SHFDPAXSPS0.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups built to the SHFDPAXSPS0 Meta switch or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the SHFDPAXSDS0 DMS10 switch will be required to reposition the codes to the SHFDPAXSPS0 Meta switch.

All ASRs for the SHFDPAXSPS0 Meta Switch must be received no later than November 6, 2023 in order to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the SHFDPAXSDS0 DMS10 switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the SHFDPAXSDS0 DMS10 switch (on or after November 7, 2023). This will serve to guide interconnect re-routes of Windstream traffic for native codes currently served by the SHFDPAXSDS0 DMS10 switch to reflect the SHFDPAXSPS0 Meta Switch as the new home switch. All ASRs for the SHFDPAXSPS0 Meta switch must carry the project code of SHFDPAXSPS0.
