Please note that changes in vehicle ownership can be reported electronically at www.icetra.is.

An original document must be submitted to the Icelandic Transport Authority.

It is recommended that parties keep a copy of the notification or sign an additional copy.

Both the buyer and the seller are responsible for notifying the ownership change. If the ownership change is to be registered in person, both parties must attend and present valid identification. If this is not done, an electronic notification will be sent to both parties' digital mailboxes, giving them a one-week deadline to object. If no objections are received within that period and no other obstacles are present, the ownership change will automatically be processed after 7 days.

Please note: A vehicle continues to accumulate fees while it is registered to the seller. If processing is delayed beyond the end of the month, **additional charges** may apply, such as a mileage fee.

All outstanding levies and fees must be paid before notifying a transfer of vehicle ownership.

Note that public fees cannot be paid at Samgöngustofa. Road tax: The registered owner on the due date (January 1st and July 1st each year) is responsible for the payment of road tax. The Iceland Revenue and Customs will issue a reimbursement to the seller and send an invoice to the buyer. **Negligence fee:** It is prohibited to register a transfer of vehicle ownership if a negligence fee has been levied. **Kilometer fee for heavy vehicles and trailers:** The owner or keeper of a vehicle with a vehicle meter must present the vehicle for an odometer reading and pay a kilometer fee, no more than 7 days prior to notifying a transfer of vehicle ownership. **Kilometer fee for electric, hydrogen and plug-in hybrid cars:** An odometer reading must be specified for all electric, hydrogen and plug-in hybrid cars. The buyer verifies the odometer reading with their signature. The seller will receive an invoice from the Iceland Revenue and Customs and the buyer will start to pay kilometer fees from the registered date of ownership.

Payment: The cost for a transfer of vehicle ownership is kr. 2.955 kr. in accordance with the Icelandic Transport Authority's tariff. If paid by bank transfer, the account number is 515-26-210867 and ID no. (is. kennitala) 540513-1040.
