Supporting Documents

The application must be supported by the following documents:

- 1) Drivers card: Photocopy of the applicant's driving license (both sides). If the applicant delivers the application at Samgongustofa he/she must present the driving license. A passport photo shall be submitted along with the application if applying for the first time. The photo shall be a portrait of the applicant, without a headgear, 35mm x 45mm in size on a long-lasting photographic paper without stamps or logos.
- 2) Workshop card: Accreditation certificate needs to be presented and a photocopy of a valid passport or driving license from the technical director. If the applicant delivers the application at Samgöngustofa he/she/it must present valid IDs.
- 3) Expenses: The fee for the digital tachograph card is ISK 19.081. If the applicant requests that the card be sent to his/her home address the fee is ISK 20.326. The application will not be processed until a full payment has been made. Applicants can pay by making a deposit into Samgöngustofa's bank account (515-26-210867, ID. No./kennitala 540513-1040), or by paying at the service desk at Samgöngustofa.

Drivers card applicants need to fulfil following condition:

- 1) Valid driving license issued in an EEA State with a valid C1-, C-, D1- or D-class.
- 2) Have permanent residence in Iceland.

Reissuing a drivers card:

Each driver is only permitted to have one drivers card. Upon reissuing the older card must be returned.
