

## Access Agreement

We, the undersigned, the parents of the child/children

In addition to the above, the following conditions shall apply to access (unless otherwise decided):

The father/mother shall collect the child/children from his/her/their home at the start of the access period and bring him/her/them back there at the end of the period.

The costs involved in access shall be borne by the parent exercising the right of access.

If, due to unavoidable circumstances, e.g. bad weather, impassable roads, illness, etc., access cannot take place as provided for in this Agreement, access shall lapse on that occasion, and there shall be no obligation to make it up later. The other parent shall be informed as soon as possible if access cannot take place.

This Agreement is permanent / shall be in force for \_\_\_ months on a trial basis, after which time either of us may request that it be reviewed, in part or in its entirety. However, the Agreement shall remain in force without amendment until a new agreement or ruling takes effect.

If there are substantial changes in the premises on which this Agreement is based, or in our personal circumstances in other respects, e.g. due to movement to a new place of residence, either of us may request a review of this Agreement, or a ruling by the district commissioner, at a date earlier than is stated above.

This Agreement takes effect as from the date of signature on \_\_\_\_\_ 20\_\_.

By signing this Agreement we promise to be governed by it and commit ourselves to complying with it in every respect.

At the same time, we confirm by signing this Agreement that we have read it and acquainted ourselves thoroughly with its contents.

Finally, we confirm that we have acquainted ourselves with the contents of the Children's Act regarding the legal implications of approval by a district commissioner, and we realise that compliance with **an approved agreement** can be enforced by the imposition of *per diem fines* or **enforcement measures**.
