WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the Income Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. WHAT ARE THE RISKS OF INVESTING?



HOW HAS THE FUND PERFORMED?

ANNUAL RETURN GRAPH

WHAT FEES ARE INVESTORS CHARGED?

Investors in the Income Fund are charged fund charges that include GST. In the year to 31 March 2022 these were:


EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Katie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katie incurred a loss after fund charges were deducted of -\$505 (that is -5.05% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total loss after tax of -\$505 for the year.

Currency hedging

The benchmark currency hedge ratio for International fixed interest is 100% hedged into NZD. At quarter end the fund was 100.9% hedged into NZD.
