#### WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. # WHAT FEES ARE INVESTORS CHARGED?

Investors in the Growth Fund are charged fund charges that include GST. In the year to 31 March 2019 these were:

# EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Katie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katie received a return after fund charges were deducted of \$757 (that is 7.57% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total return after tax of \$757 for the period.

- <sup>1</sup> Market index returns as well as the fund's actual returns have been used to fill in the risk indicator, as the fund commenced less than 5 years ago. As a result of market index returns being used, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. Market index returns were used for the period from 1 October 2014 to 31 July 2018.
- <sup>2</sup> The Growth Fund was introduced on 31 July 2018. The annual fund charges have been estimated by annualising the eight months fees and expenses to 31 March 2019 and using the 30 June 2019 net asset value for the fund.
- <sup>3</sup> Total performance-based fees is the amount incurred by the fund for the year ended 31 March 2019. The performance-based fee accrual is calculated on a daily basis. See the product disclosure statement for more information about the basis on which performance fees are charged.
