#### WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the Property & Infrastructure Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



#### **HOW HAS THE FUND PERFORMED?**

# WHAT FEES ARE INVESTORS CHARGED?

Investors in the Property & Infrastructure Fund are charged fund charges that include GST. In the year to 31 March 2020 these were:

# EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Katie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katie received a return after fund charges were deducted of \$300 (that is 3.00% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total return after tax of \$300 for the year.

## **Currency hedging**

The benchmark currency hedge ratio for Australian and international assets is 70% hedged into NZD. At quarter end the fund was 68.3% hedged into NZD.
