## WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the Balanced Strategy has performed and what fees were charged. The document will help you to compare the fund with other funds. Fisher Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## DESCRIPTION OF THIS FUND

This investment option aims to provide a balance between protecting your investment and growing it over the long term. Invests in a balance of income and growth assets, and automatically rebalanced each year to the target investment mix of 45% Conservative Fund and 55% Growth Fund.

## WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the Balanced Strategy<sup>1</sup>:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

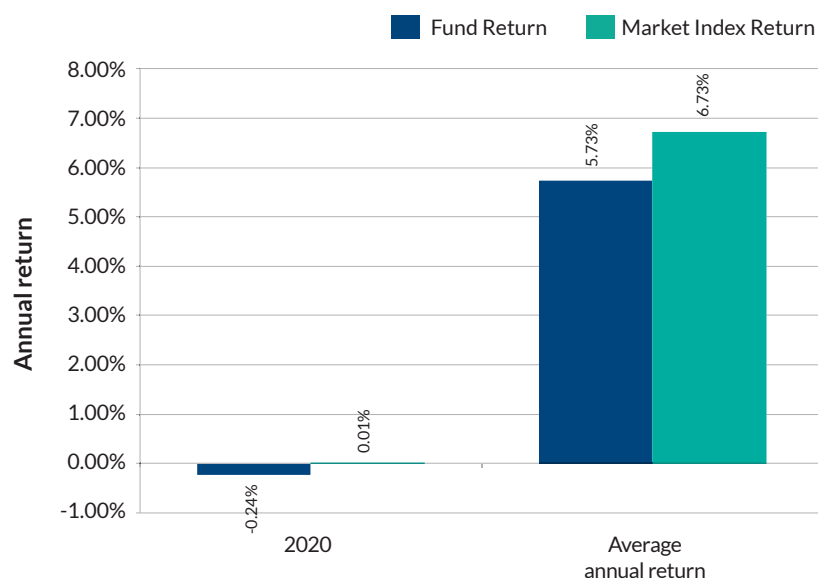

## HOW HAS THE FUND PERFORMED?

## ANNUAL RETURN GRAPH



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 30 June 2020.

## WHAT FEES ARE INVESTORS CHARGED?

Investors in the Balanced Strategy are charged fund charges that include GST. In the year to 31 March 2020 these were:

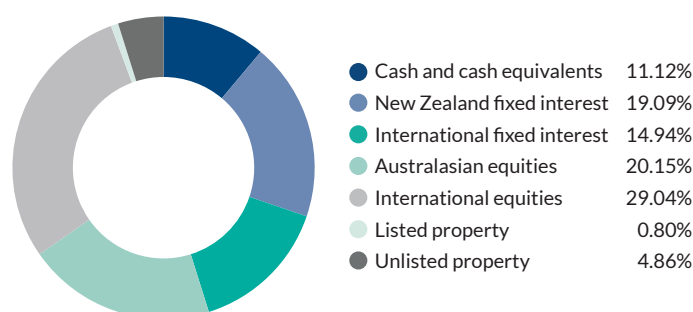
## EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Katie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katie received a return after fund charges were deducted of \$501 (that is 5.01% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total return after tax of \$501 for the period.

## WHAT DOES THE FUND INVEST IN?

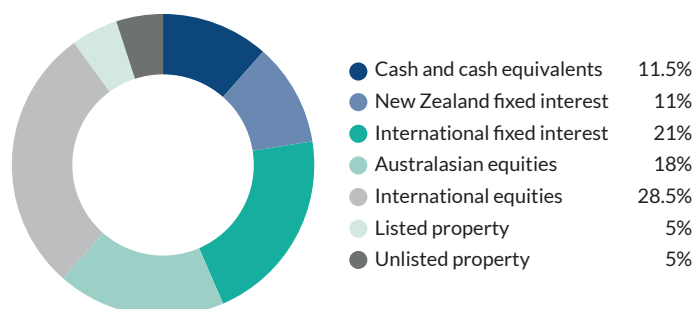
### Actual investment mix

<sup>1</sup> Market index returns as well as the fund's actual returns have been used to fill in the risk indicator, as the fund commenced less than 5 years ago. Market index returns were used for the period from 1 July 2015 to 31 July 2018.

<sup>2</sup> The total fund charge for the Balanced Strategy is estimated using 45% of the Conservative Fund total fund charge and 55% of the Growth Fund total fund charge.
