WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Fisher Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

The fund aims to grow your investment with more focus on capital growth over the long term. Invested in mainly growth assets.

WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the Growth Fund¹:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

WHAT FEES ARE INVESTORS CHARGED?

Investors in the Growth Fund are charged fund charges that include GST. In the year to 31 March 2019 these were:

EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Katie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katie received a return after fund charges were deducted of \$2,008 (that is 20.08% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total return after tax of \$2,008 for the period.

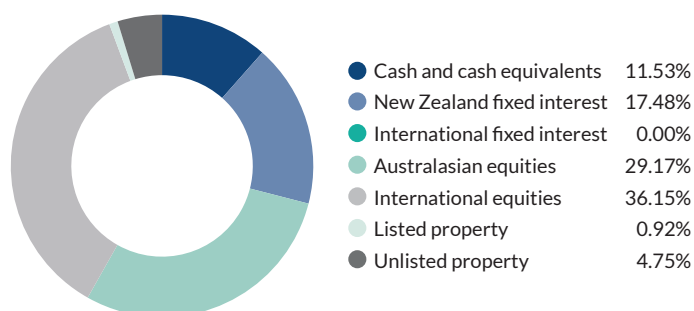

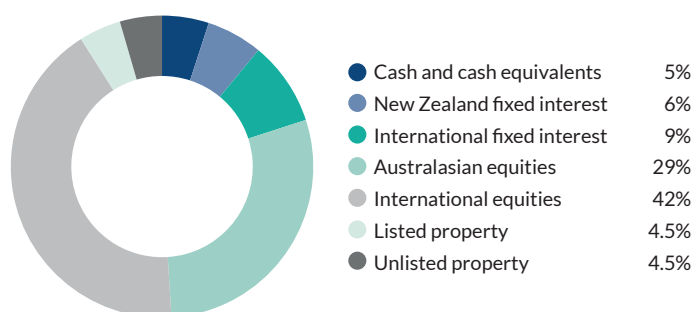
Actual investment mix

NOTES

- ¹ Market index returns as well as the fund's actual returns have been used to fill in the risk indicator, as the fund commenced less than 5 years ago. As a result of market index returns being used, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. Market index returns were used for the period from 1 January 2015 to 31 July 2018.
- ² The Growth Fund was introduced on 31 July 2018. The annual fund charges have been estimated by annualising the eight months fees and expenses to 31 March 2019 and using the 30 June 2019 net asset value for the fund.
- ³ Total performance-based fees is the amount incurred by the fund for the year ended 31 March 2019. The performance-based fee accrual is calculated on a daily basis. See the product disclosure statement for more information about the basis on which performance fees are charged.
