WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Fisher Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

DESCRIPTION OF THIS FUND

The fund aims to provide moderate protection for your investment, while also providing a modest level of return over the medium term. Invests in mainly income assets with a small amount in growth assets.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

HOW HAS THE FUND PERFORMED?

WHAT FEES ARE INVESTORS CHARGED?

EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Katie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katie received a return after fund charges were deducted of \$570 (that is 5.70% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total return after tax of \$570 for the period.

NOTES

- ¹ Market index returns as well as the fund's actual returns have been used to fill in the risk indicator, as the fund commenced less than 5 years ago. As a result of market index returns being used, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. Market index returns were used for the period from 1 October 2014 to 31 July 2018.
- ² The Conservative Fund was introduced on 31 July 2018. The annual fund charges have been estimated by annualising the eight months fees and expenses to 31 March 2019 and using the 30 June 2019 net asset value for the fund.
