#### WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Fisher Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### **DESCRIPTION OF THIS FUND**

The fund aims to provide moderate protection for your investment, while also providing a modest level of return over the medium term. Invests in mainly income assets with a small amount in growth assets.

# WHAT FEES ARE INVESTORS CHARGED?

Investors in the Conservative Fund are charged fund charges that include GST. In the year to 31 March 2018 these were:

# EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Katie had \$10,000 in the fund at 31 July 2018 and did not make any further contributions. At 31 March 2019, Katie received a return after fund charges were deducted of \$293 (that is 2.93% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total return after tax of \$293 for the period.
