WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the Australian Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. WHAT ARE THE RISKS OF INVESTING?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



HOW HAS THE FUND PERFORMED?

WHAT FEES ARE INVESTORS CHARGED?

Investors in the Australian Growth Fund are charged fund charges that include GST. In the year to 31 March 2022 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.

EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Katie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katie incurred a loss after fund charges were deducted of -\$1,579 (that is -15.79% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total loss after tax of -\$1,579 for the year.

Currency hedging

The benchmark currency hedge ratio for Australian equities is 70% hedged into NZD. At quarter end the fund was 72.0% hedged into NZD.

NOTES

¹ Total performance-based fees is the amount incurred by the fund for the year ended 31 March 2022. The performance-based fee accrual is calculated on a daily basis. From 1 July 2021 the performance-based fee is capped at 2% of the fund's average net asset value per year.
