What is the purpose of this update?

This document tells you how the Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The fund aims to grow your investment with more focus on capital growth over the long term. Invested in mainly growth assets.

What fees are investors charged?

Investors in the Growth Fund are charged fund charges that include GST. In the year to 31 March 2018 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Katie had \$10,000 in the fund at 31 July 2018 and did not make any further contributions. At 30 September 2018, Katie received a return after fund charges were deducted of \$263 (that is 2.63% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total return after tax of \$263 for the period.

Notes

- ¹ Market index returns as well as the fund's actual returns have been used to fill in the risk indicator, as the fund commenced less than 5 years ago. Market index returns were used for the period from 1 October 2013 to 31 July 2018.
