WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Fisher Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

The fund aims to grow your savings with more focus on capital growth over the long term. Invested in mainly growth assets.

WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the Growth Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

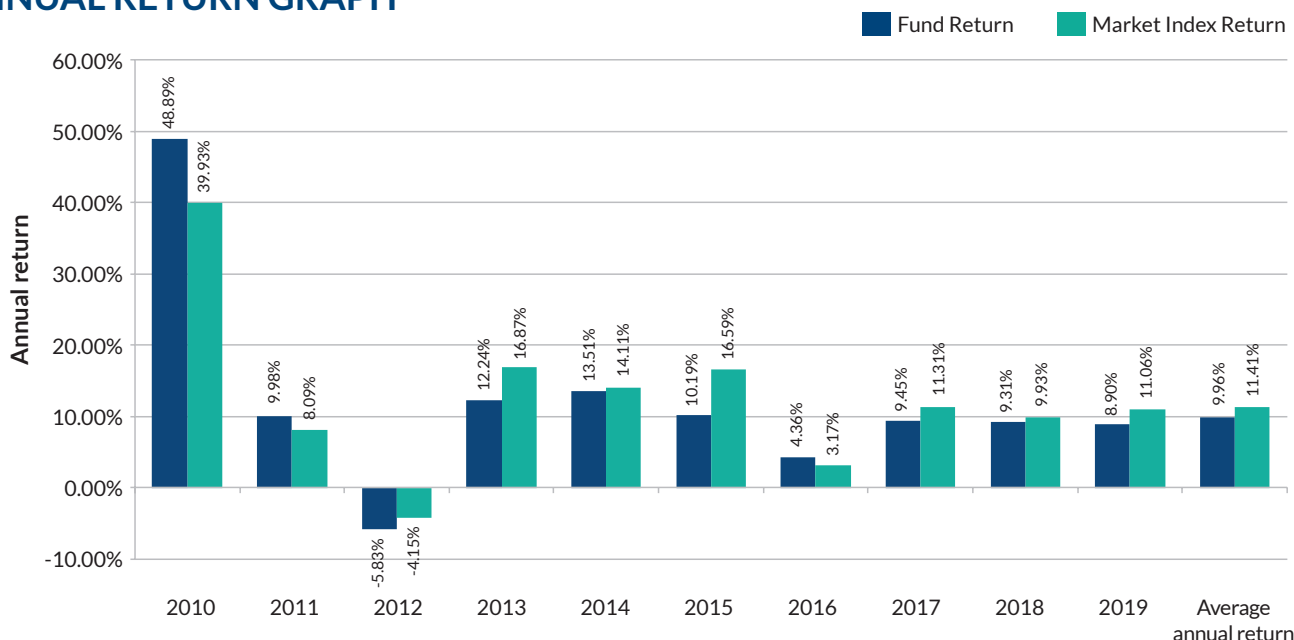

HOW HAS THE FUND PERFORMED?

ANNUAL RETURN GRAPH

WHAT FEES ARE INVESTORS CHARGED?

Small differences in fees and charges can have a big impact on your investment over the long term.

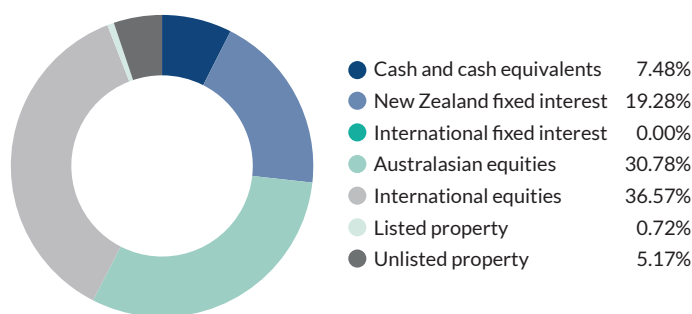
EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$788 (that is 7.88% of her initial \$10,000). Sarah also paid \$36 in other charges. This gives Sarah a total return after tax of \$752 for the year.

WHAT DOES THE FUND INVEST IN?

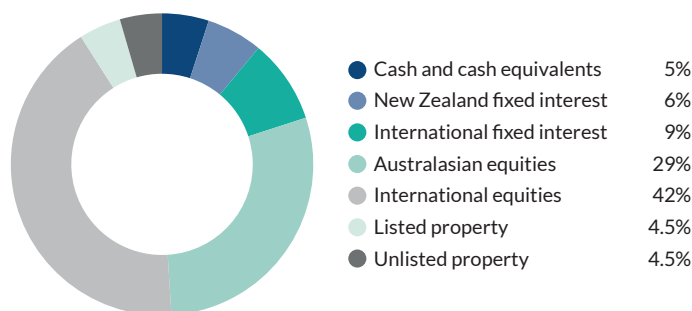
Actual investment mix
