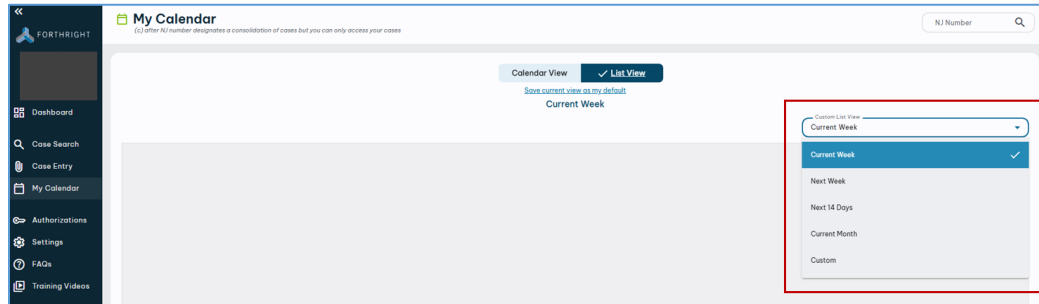

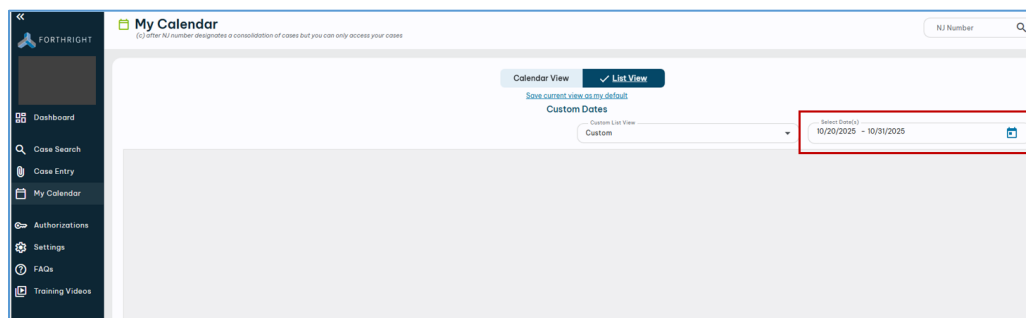
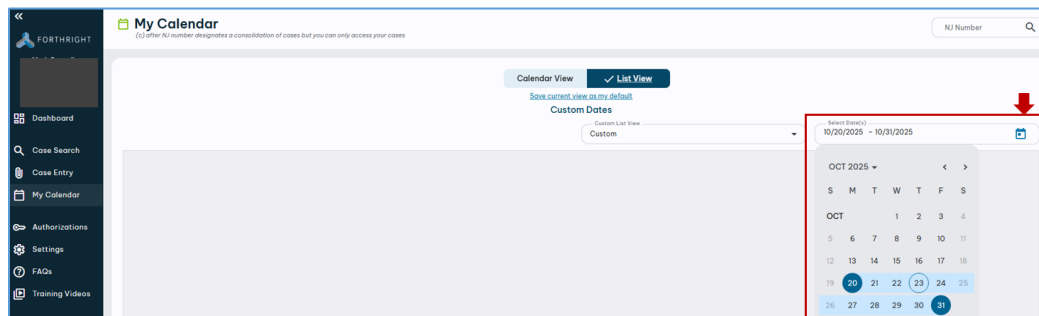
CALENDAR

The date range on your Calendar is customizable

When viewing your calendar you can customize the date range. The Custom List View provides preset ranges for the Current Week, Next Week, Next 14 Days, Current Month, or the ability to set your own custom range by choosing a start date and end date.



If you choose Custom, you have the opportunity to set any range you like by clicking the calendar icon and picking your start date and end date.



Calendar will now maintain the date selected

When working in your Calendar, the portal will maintain the date or date range being viewed when navigating away and back to the Calendar.

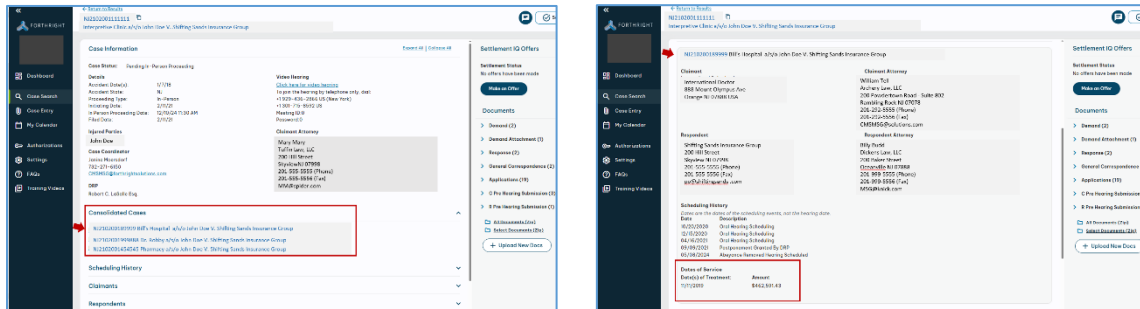
Ability to see the DRP name for each case listed

By hovering over the case link, you can view the name of the DRP hearing the case.

CASE MANAGEMENT

On the Case Information page, expanded view of consolidated case information

When working on your case on the Case Information page, you can click on [Consolidations](#) to see the other matters consolidated with your case. Now the information provided will include the ***dates of service and the amount claimed*** in the other cases, as well as the claimant, claimant attorney contact information, and scheduling history.



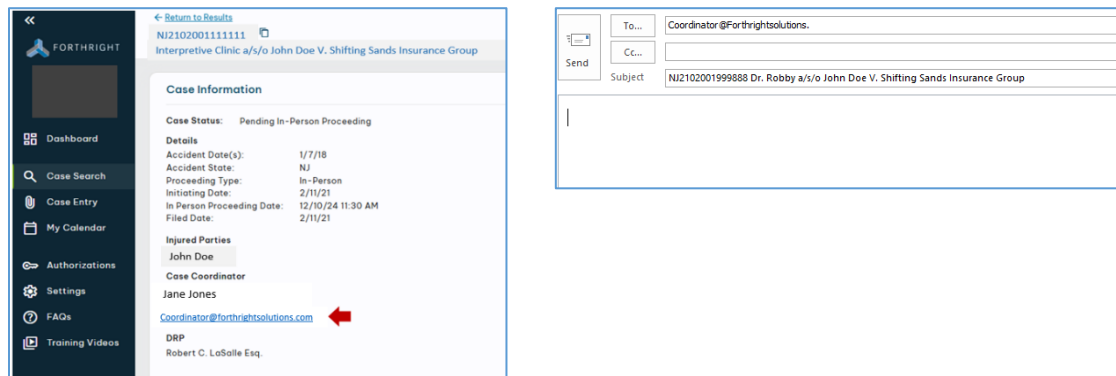
The Fortnight number and case name can be copied with one click

By clicking the copy icon next to the Fortnight number you will copy the number AND case name on a single line and can paste it in an email subject or anywhere else you like.



Emails to the coordinator will prepopulate the coordinator's address and the case number and name in the subject

By clicking on the coordinator's email address in the case, your email will prepopulate.



SETTLEMENT IQ OFFERS

In Settlement IQ, whenever a claim is amended any outstanding SIQ offer will be rejected/revoked and the system will invite a new offer

If the amount of the claim is amended by any party and there is a pending offer in Settlement IQ, the pending offer will be rejected/revoked. Either party can then make a new offer and the case history will reflect the prior offer and status.

In SIQ, your offer can include interest “By Respondent”

When making an offer or counteroffer, you can now waive or indicate the interest will be calculated by the Respondent.

In SIQ, the amount of settlement now appears on the Case Management page
