

END USER LICENSE AGREEMENT

If you ("Customer") have purchased the right to access and use the Services from a Reseller, this end user license agreement ("Agreement") shall apply as of the Effective Date.

In addition to any terms and conditions related to Customer's use of the Service pursuant to a Purchase Order, this Agreement contains the terms and conditions that govern Customer's access to and use of the Service. Beamery is an express beneficiary of this Agreement, and in acquiring the right to access and use of the Services, Customer expressly acknowledges and agree that Beamery shall have the right to legally enforce this Agreement against Customer and that this Agreement constitutes the entire agreement and supersedes any and all prior agreements between Customer and Beamery with regard to the access and use of the Services and any Purchase Order.

By accessing or using the Services (including permitting Authorized Users to do so) or entering into a Purchase Order, Customer agrees to be legally bound by this Agreement. If you are an individual acting on behalf of a company, organization, or another legal entity, you represent and warrant that you have the authority to enter into this Agreement on behalf of such entity and its Affiliates, in which case in which case the term "Customer" herein refers to such entity and its Affiliates. If you do not have such authority, or if Customer does not agree with this Agreement, Customer must not use or authorize any use of the Services. Subscriber and Beamery shall each be referred to as a "party" and collectively referred to as the "parties" for purposes of this Agreement.

AGREED TERMS

1. DEFINITIONS

- 1.1 **Affiliates** means any third-party that controls, is controlled by or is under common control with, the applicable party. As used herein, "control" means the possession, direct or indirect, of the power to direct or cause the direction of the management and policies of said party, whether through ownership of voting securities, by contract or otherwise.
- 1.2 **Applicable Laws** means worldwide laws and regulation in force from time to time that are applicable to the Services, including but not limited to Data Protection Laws.
- 1.3 **Authorized Users** means the nominated personnel of Customer, its Affiliates or its partners who are issued with a unique live login to the Subscription Service.
- 1.4 **Beamery** means the Beamery entity set out in the applicable Resale Order.
- 1.5 Beta Services means a version or feature of the Services that Beamery has not made generally available for production use.
- 1.6 **Confidential Information** means any information (regardless of its form), which is designated by a party, its Affiliates or Sub-Processors, as being confidential (whether or not it is marked) or which can reasonably be expected to be confidential, that the other party obtains in connection with this Agreement, including but not limited to: Customer Data; Documentation; pricing; the terms and conditions of this Agreement; terms and conditions of the Reseller Agreement, technical information or know-how; recordings of the Services; trade or business secrets; and commercial information.
- 1.7 **Contact** means a single candidate, prospect, lead, or other individual (other than an Authorized User) whose information and Personal Data is submitted to the Subscription Service.
- 1.8 **Customer Data** means the data provided by Customer for the purpose of using the Services including Contact information, text, graphics, information, documentation, content, notes, images, data, and other materials.
- 1.9 Data Protection Law means worldwide data protection and privacy laws and regulations in force from time to time, and the guidance and codes of practice issued by the relevant data protection or supervisory authority, that are applicable to a party in its use or provision of the Services and Personal Data, including, where applicable and in each case as may be amended or superseded from time to time Regulation (EU) 2016/679 (General Data Protection Regulation "GDPR"), UK GDPR and US equivalents.
- 1.10 **Documentation** means the Resale Order and documentation specifying the functionalities or limitations of the Services made available by Beamery to Customer and/or Reseller.
- 1.11 **DPA** means the Data Processing Agreement in Exhibit 1.
- 1.12 **Effective Date** means the earlier of the date that: (a) Customer or its Authorized Users gain access to or use the Services; or (b) the start date in the applicable Resale Order.
- 1.13 **Enrichment Data** means data pertaining to a Contact that is generated from publicly available sources via Sub-Processors that is made available to Customer as part of the Subscription Service.
- 1.14 **Force Majeure** means any cause preventing a party from performing any or all of its obligations which arises from or is attributable to acts, events, omissions or accidents beyond the reasonable control of the party so prevented including, without limitation, act of God, war, riot, computer viruses and malware, epidemics, pandemics, compliance with any law or governmental order, rule, regulation or direction, flood or storm, except for strike or lockout of the party's own staff shall not entitle them to claim that to be a force majeure event.
- 1.15 **Intellectual Property Rights** means all tangible and intangible rights associated with works of authorship throughout the world, including, but not limited to, copyrights, moral rights, and mask works; trademarks and trade name rights and similar rights; trade secret rights; patents, designs, algorithms, and other intellectual or industrial property rights (of every kind and nature) whether registered, registerable or otherwise arising by operation of law, contract, license, or otherwise; and all

registrations, initial applications, renewals, extensions, continuations, divisions, or reissues now or hereafter in force (including any rights in the foregoing).

- 1.16 **Professional Services** means implementation, integration, consulting, advising, and/or training services that are purchased by Reseller on Customer's behalf under a Resale Order.
- 1.17 **Purchase Order** means an agreement and/or ordering document entered into between Reseller and Customer for the purchase of the Services.
- 1.18 **Resale Order** means the ordering document entered into between Reseller and Beamery for the provision of the Services to Customer.
- 1.19 **Reseller** means a third party, who is authorized to sell the Services under a Reseller Agreement.
- 1.20 **Reseller Agreement** means the agreement between Reseller and Beamery that permits Reseller to sell the Services to the Customer subject to certain terms and conditions.
- 1.21 **Restricted Information** means payment card information; financial information (or similar data regulated by GLBA or equivalent legislation); social security numbers; passport numbers; driving license numbers; insurance information; physical or mental health information or medical conditions (or similar data regulated by HIPAA or equivalent legislation); political opinions; religious or philosophical beliefs; trade union membership; genetic data; biometric data; sex life; or criminal information and/or background checks. Restricted Information does not include voluntarily-given self-identification data such as gender, sexual orientation, racial or ethnic data, or vaccination status.
- 1.22 **Security Policies** means Beamery's documentation with regards to information security and data privacy at www.beamery.com/policy/security as amended from time to time. Beamery shall not materially diminish the technical and organizational measures set out in its Security Policies.
- 1.23 Services means, collectively (as applicable), the Subscription Service and Professional Services.
- 1.24 **SLA** means the "service level agreement (SLA)" at https://beamery.com/terms-and-conditions, as amended from time to time. Beamery shall not materially diminish the service levels set out in the SLA.
- 1.25 **Sub-Processors** means Beamery's sub-processors set out under "Sub-Processors" at https://beamery.com/terms-and-conditions, as updated from time to time. Changes in the Sub-Processors shall be made in accordance with the DPA.
- 1.26 **Subscription Service(s)** means Beamery's software as a service tools and platform, any ancillary products and services, including website hosting and support services purchased by Reseller on Customer's behalf under a Resale Order.
- 1.27 **Third Party Services** means any applications, products, applicant tracking systems, links, and services not provided by Beamery that are used by Customer in conjunction with the Services.

2. SUPPLY OF SERVICES

- 2.1 **Subscription Service**. Beamery shall provide Customer with access to the Subscription Service for the term set out in the applicable Resale Order.
- 2.2 Support and Service Levels. Beamery shall provide support for the Subscription Services in accordance with the SLA.
- 2.3 **Professional Services.** Supplier will provide Professional Services as set out in the applicable Resale Order. Beamery shall not be responsible or liable for any delay in providing the Professional Services that is caused in whole or in part by an act or omission of Customer or its Affiliates, or any of their Authorized Users, or third parties.
- 2.4 **Customer Affiliates**. Customer's Affiliates may use the Services provided that Customer shall be responsible for the acts and omissions of such of its Affiliates, including Affiliates' compliance with the terms the Agreement.
- 2.5 **Enrichment Data.** Beamery shall provide Customer with Enrichment Data as part of its provision of the Subscription Services. Customer acknowledges that Beamery provides this service via its Sub-Processors.
- 2.6 **Beta Services**. Customer may use any Beta Services offered by Beamery at no charge. Beta Services: (a) are provided AS IS with no warranty/liability and are for evaluation and testing purposes only; (b) are not subject to the SLA; and (c) may be subject to additional terms (as provided by Beamery from time to time). Beamery may discontinue Beta Services at any time in its sole discretion and without any liability, and Customer acknowledges that Beamery may never make them generally available. If Beamery makes a production version of any Beta Services, the Beta Services will automatically cease.
- 2.7 **Third Party Services.** Customer may elect to use the Services in conjunction with Third Party Services. Customer acknowledges that its use of such Third Party Services is subject to the applicable third party's terms and conditions and Beamery makes no representations or warranties in relation to such Third Party Services including continuous availability of Third Party Services.

3. BEAMERY WARRANTIES

3.1 Performance Warranty. Beamery warrants that: (a) the Services shall substantially perform in accordance with the Documentation during the Term; and (b) the support services and Professional Services will be rendered with due care, skill and ability, and in accordance with recognized industry standard practices. If the Services do not conform to the performance warranty in this Section 3.1 Beamery will, at its expense, correct any such non-conformance, or provide Customer with an alternative means of accomplishing the performance. If Beamery cannot correct or substitute such non-conformance, either party may terminate the non-conforming Services and Customer will receive a pro-rata refund for such non-conforming Services. Such correction, substitution, or termination with a pro-rata refund constitutes Customer's sole and exclusive remedy in connection with any non-conformance with the performance warranty in this Section 3.1. Beamery shall not be liable for any non-conformance of the Services to the extent that such non-conformance arises due to the use of the Services

by or on behalf of Customer contrary to this Agreement, Documentation, Beamery's express instructions, or any modification or alteration of the Services by any party other than Beamery.

- 3.2 Legal Warranty. Beamery warrants that it shall comply with all Applicable Laws in its performance of the Services.
- 3.3 Viruses. Beamery will use industry-standard measures to avoid introducing viruses into the Subscription Services.
- 3.4 **DISCLAIMER**. EXCEPT AS SET FORTH UNDER THIS <u>SECTION 3.4</u> OR AS OTHERWISE SPECIFIED IN THIS AGREEMENT, BEAMERY MAKES NO OTHER WARRANTY WITH RESPECT TO THE SERVICES, AND DISCLAIMS ALL STATUTORY OR IMPLIED WARRANTIES, INCLUDING WITHOUT LIMITATION WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE OR CUSTOMERS' BUSINESS REQUIREMENTS. BEAMERY DOES NOT WARRANT THAT THE SERVICES ARE ERROR-FREE, UNINTERRUPTED, OR CONTINUOUS OR THAT IT IS COMPATIBLE WITH CUSTOMER'S SYSTEMS (OTHER THAN AS SPECIFIED IN THE DOCUMENTATION). BEAMERY MAKES NO WARRANTY AS TO THE ACCURACY OF ITS ALGORITHMS. BEAMERY SHALL HAVE NO LIABILITY FOR ANY LOSS, OR DAMAGE THAT IS CAUSED BY ERRORS OR OMISSIONS IN ANY INFORMATION, DATA, INSTRUCTIONS, OR SCRIPTS PROVIDED TO BEAMERY BY CUSTOMER, OR ANY ACTIONS TAKEN BY BEAMERY AT CUSTOMER'S DIRECTION. BEAMERY MAKES NO REPRESENTATIONS OR WARRANTIES IN RELATION TO ITS ARTIFICIAL INTELLIGENCE AUDIT.

4. CUSTOMER OBLIGATIONS

4.1 Users and Limits. Customer shall use the Subscription Services in accordance with the limits in the applicable Resale Order and Beamery's "fair use policy" (available at https://beamery.com/terms-and-conditions/). Customer shall notify Beamery promptly if it becomes aware that it is over its limits or if any Authorized User's login details have been shared, compromised, or subject to unauthorized disclosure. If Authorized Users have shared login details with another person or Customer is otherwise over its limits, then without prejudice to Beamery's other rights, Customer shall pay to Beamery an amount equal to the fees that would have been payable for the additional limits. Customer shall be liable for the acts and omissions of its Authorized Users.

4.2 **Prohibited and Unauthorized Use**. Customer shall not:

- (a) use the Service to collect, manage or process Restricted Information;
- (b) use the Services to email purchased lists without proper consent from the recipient;
- (c) attempt to gain unauthorized access to the Services;
- (d) use the Services in a way that threatens the security, integrity, or availability of the Services, including but not limited to uploading content or files that contains viruses, malware, or malicious code and sending spam emails;
- directly or indirectly, reverse engineer, decompile, disassemble or otherwise attempt to discover or disclose to any third party the source code, object code or underlying structure, ideas, know-how or algorithms relevant to the Services;
- (f) sell, resell, license, sublicense, distribute, rent, lease or make available the Services or Documentation to any third party; and
- (g) use the Services in a manner that facilitates bias or discriminatory practices, whether intentional or inadvertent, based on sensitive or protected categories or characteristics.
- 4.3 **Legal Warranty.** Customer shall use the Services in compliance with all Applicable Laws. Customer acknowledges that the Subscription Services has functionality to enable Customer's compliance with certain laws (for example accessibility, data protection, hiring, and artificial intelligence) however Customer is responsible for using such functionality in compliance with Applicable Laws.
- 4.4 **Suspension for Unauthorized Use.** Beamery may suspend, in its reasonable discretion, any user's access to the Services, for breach of <u>Sections 4.2</u> or <u>4.3</u>. Beamery will notify Customer of such suspension as soon as practicably possible. Any suspension shall be as limited in scope and duration as reasonably possible.
- 4.5 **SMS Services**. If Customer uses Beamery's SMS services, Customer will complete the following form prior to using such services: https://beamery.typeform.com/to/MFRH1ucS.

5. TERMINATION & SUSPENSION

- 5.1 **Term.** This Agreement shall govern all Customer's and Authorized Users access to and use of the Services and shall continue from the Effective Date until the earlier of expiry of all Resale Orders or termination of the Services in accordance with this Agreement ("**Term**").
- 5.2 **Termination for Cause.** A party may terminate this Agreement by giving written notice of such termination to the other party:
 - a) if the other party commits a material breach of any term of this Agreement and fails to remedy that breach within a period of thirty (30) days after being notified in writing to do so; or
 - b) immediately upon the occurrence of the other party having a receiver, administrative receiver or an administrator appointed, passing a resolution for winding up or a court of competent jurisdiction making an order to that effect, becoming subject to an administration order, entering a voluntary arrangement with its creditors or any equivalent to the foregoing occurring under national or local law, except where for the purposes of a solvent and bona fide amalgamation or reorganization.
- 5.3 **Reseller Termination.** Beamery may, without liability to Customer, suspend or terminate Customer's rights to access and/or use the Services if: (a) Beamery is informed by Reseller that Customer has failed to pay amounts due to Reseller under a Purchase Order; or (b) Reseller fails comply with the terms of the Reseller Agreement. Customer's sole recourse with respect to any such suspension or termination shall be against Reseller.
- 5.4 **Effect of Termination.** Upon termination or expiration of this Agreement:

- a) all rights to use the Services shall terminate immediately;
- b) Customer shall promptly pay any fees, taxes, or other amounts due; and
- c) in the case of termination by Customer for cause under <u>Section 5.2(a)</u> Customer will receive a pro-rata refund as applicable to the breach.
- 5.5 **Liability for suspension and termination**. Customer consent to these suspension and termination rights and acknowledge and agree that Beamery shall have no liability to Customer of any kind with respect to any such suspension or termination. Customer's sole recourse with respect to any such suspension or termination shall be against Reseller.
- 5.6 **Retrieval & Deletion of Customer Data.** Customer may export copies of Customer Data in .csv format at any time during the Term. Unless otherwise agreed with Customer or legally prohibited, Beamery will, delete in accordance with industry standards, all Customer Data in its production environment thirty (30) days after termination or expiration of this Agreement and all backups ninety (90) days thereafter.

6. PROPRIETARY RIGHTS

- 6.1 **Customer's Proprietary Rights.** Customer remains the sole owner of all Intellectual Property Rights in Customer Data. Customer warrants that Beamery's use of Customer Data in in connection with this Agreement shall not cause Beamery to infringe any Applicable Laws or third-party Intellectual Property Rights.
- 6.2 **Beamery's Proprietary Rights**. This is an Agreement for access to and use of the Services as set out herein. Beamery and its licensors remain the sole owner of all Intellectual Property Rights and other right, title, and interest in the Documentation, Beamery's trademarks and service marks, and the Services and related software. Beamery does not grant Customer any Intellectual Property Rights under this Agreement.
- 6.3 **Feedback**. Customer may provide feedback regarding any part of the Services, products, business or development plans, or technology roadmaps ("**Feedback**"). Beamery may collect data from Customer's use of the Services ("**Usage Data**") for development, artificial intelligence learning, benchmarking, reporting, analysis, and for other lawful business purposes. However, Beamery will not disclose Usage Data externally unless it is in a form that does not permit direct association with Customer, its Authorized Users or any individual. Beamery shall own all right, title, and interest in all Usage Data and Feedback.

7. CONFIDENTIALITY

- 7.1 **Confidentiality Undertaking**. Each party shall (a) not use the other party's Confidential Information other than as required for the performance of its obligations under this Agreement; (b) not disclose the other party's Confidential Information to any third party (except its Affiliates, Sub-Processors, professional advisors or as required by Applicable Law) without the prior written consent of the other party; and (c) use reasonable efforts (not less than it uses to protect its own confidential information) to prevent the unauthorized disclosure of the other party's Confidential Information. Notwithstanding the foregoing, Customer permits Beamery to disclose, under obligations of confidentiality no less onerous than those set out herein, that Customer is a customer of Beamery to actual or potential clients, partners, and investors.
- 7.2 **Exceptions.** Confidential Information shall not include any information which: (a) is or becomes publicly known other than through any act or omission of the receiving party; b) was in the other party's lawful possession before the disclosure; (c) is lawfully disclosed to the receiving party by a third party without restriction on disclosure; or (d) was or is independently developed by the receiving party without reference to the Confidential Information of the other party.
- 7.3 Required Disclosure. If a receiving party is required to disclose Confidential Information of the other party under applicable law, court order or other governmental authority lawfully demanding the Confidential Information, the receiving party shall: (a) to the extent legally permissible, give to the disclosing party prompt written notice of the request and a reasonable opportunity to object to the disclosure and to seek a protective order or other appropriate remedy; (b) use reasonable efforts to limit disclosure; (c) disclose only the Confidential Information specifically required and only to the extent compelled to do so; and (d) continue to maintain confidentiality after the required disclosure.

8. DATA & SECURITY

- 8.1 **Data Protection**. Both parties shall comply with their obligations under Data Protection Law and in particular those set out in the DPA. For the avoidance of doubt, for the purposes of Applicable Data Protection Law, Reseller is not a processing party to this Agreement.
- 8.2 **Security**. Beamery will maintain appropriate administrative, physical, and technical safeguards for protection of the security, confidentiality, and integrity of Customer Data, as further described at the Security Policy and Annex 2 of the DPA. Those safeguards will include, but will not be limited to, measures designed to protect against the unauthorized access to or disclosure of Customer Data.
- 8.3 **Customer Data Protection.** Customer acknowledges that it is the Controller of the Customer Data and as such Customer warrants that it shall use the Services in compliance with all applicable Data Protection Laws and that it has all necessary consents (or other lawful basis) to transfer the Customer Data to Beamery. Customer will defend and indemnify Beamery and its Affiliates (and their respective employees, directors, and representatives) from all claims or demands by a third party, including all damages, liabilities, costs, reasonable attorneys' fees, and fines imposed by legal or regulatory bodies, to the extent resulting from, alleged to have resulted from or in connection with any violation by Customer or its Affiliates of any applicable Data Protection Law or applicable employee hiring laws.

9. INDEMNIFICATION

- 9.1 **Beamery Indemnification**. Beamery shall defend and indemnify Customer and its Affiliates against any losses, costs, expenses (including reasonable legal costs) and damages in connection with any third-party claim or action brought against Customer to the extent that such claim directly arises from an allegation that the use of the Services (or any part thereof) infringes the Intellectual Property Rights of a third party ("IP Claim"). This Section shall not apply to the extent the IP Claim is attributable to: (a) use of the Services (or any part thereof) by or on behalf of Customer other than in accordance with the terms of this Agreement; (b) any use by or on behalf of Customer of the Services in combination with any item not supplied or recommended by Beamery where such use of the Services directly gives rise to the IP Claim; or (c) fraud, fraudulent misrepresentation, negligence or willful misconduct by or on behalf of Customer.
- 9.2 Conditions. If any third party makes a claim under any indemnity under this Agreement, or notifies an intention to make such claim against the indemnified party, the indemnified party must: (a) as soon as reasonably practicable, give written notice of the claim to the indemnifying party; (b) not make any admission of liability, agreement or compromise in relation to the claim without the prior written consent of the indemnifying party (such consent not to be unreasonably withheld or delayed); (c) allow the indemnifying party to have full control of the claim and the authority to settle or otherwise dispose of the claim, provided that the indemnifying party shall not make any admission of liability without the prior written consent of the indemnified party (such consent not to be unreasonable efforts to mitigate any damages, costs, losses, liabilities, and expenses resulting from any relevant claim; and (e) give the indemnifying party and its professional advisers reasonable assistance to enable them to assess, defend and/or settle the claim.
- 9.3 **Replacement or Modification**. In the event that the Services (or any part thereof) infringes the Intellectual Property Rights of a third party, Beamery may (at its sole discretion and expense):
 - a) modify or replace any part of the Service so that it ceases to be infringing; or
 - b) procure for Customer the right to continue to use the infringing Services (or any component part thereof).

If after a reasonable amount of time Beamery does not provide Customer with one of the options above either party may terminate the infringing Services with immediate effect and Customer will receive a pro-rata refund for any prepaid fees for the infringing part of the Services. Subject to Beamery's indemnity for IP Claims in <u>Section 9.1</u>, this <u>Section 9.3</u> states Customer's sole and exclusive rights and remedies in respect of any intellectual property infringement of the Services under this Agreement.

10. LIMITATION OF LIABILITY

- 10.1 NO LIMITATION. NOTHING IN THIS AGREEMENT EXCLUDES EITHER PARTY'S LIABILITY FOR: (A) DEATH OR PERSONAL INJURY;
 (B) GROSS NEGLIGENCE, WILLFUL MISCONDUCT, FRAUD OR FRAUDULENT MISREPRESENTATION; (C) CUSTOMER'S LIABILITY
 FOR PAYMENT OF FEES; (D) BEAMERY'S LIABILITY FOR AN IP CLAIM UNDER <u>SECTION 9.1</u>; OR (E) ANY LIABILITY THAT CANNOT BE LAWFULLY LIMITED OR EXCLUDED.
- 10.2 EXCLUDED DAMAGES. IN NO EVENT SHALL EITHER PARTY HAVE ANY LIABILITY TO THE OTHER PARTY FOR ANY LOSSES OR DAMAGES WHETHER INCURRED DIRECTLY OR INDIRECTLY OR ARE IMMEDIATE OR CONSEQUENTIAL, AND WHETHER THE SAME ARISE IN CONTRACT, TORT (INCLUDING NEGLIGENCE) OR OTHERWISE, WHICH FALL WITHIN THE FOLLOWING CATEGORIES: (A) INDIRECT, CONSEQUENTIAL, OR SPECIAL DAMAGES EVEN IF THE OTHER PARTY WAS AWARE OF THE CIRCUMSTANCES IN WHICH SUCH SPECIAL DAMAGE COULD ARISE; (B) LOSS OF PROFITS; (C) LOSS OF ANTICIPATED SAVINGS; (D) LOSS OR CORRUPTION OF CUSTOMER DATA EXCEPT TO THE EXTENT THAT BEAMERY HAS BREACHED THE AGREEMENT; (E) LOSS OF GOODWILL AND REPUTATION; (F) COST OF REPLACEMENT OF SUBSTITUTE GOODS; (G) LOSS OF BUSINESS OPPORTUNITY; OR (F) WASTED EXPENDITURE.
- 10.3 **LIMITATION OF LIABILITY**. IF EITHER PARTY IS DETERMINED TO HAVE ANY LIABILITY TO THE OTHER PARTY OR ANY THIRD PARTY UNDER OR IN CONNECTION WITH THIS AGREEMENT, EACH PARTY'S AGGREGATE LIABILITY, TOGETHER WITH THAT OF ITS OFFICERS, DIRECTORS, EMPLOYEES AFFILIATES AND AGENTS, WILL BE LIMITED TO THE TOTAL AMOUNT OF FEES PAID OR PAYABLE BY RESELLER TO BEAMERY WITH RESPECT TO THE CUSTOMER IN THE TWELVE-MONTH PERIOD PRECEDING THE EVENT GIVING RISE TO ANY CLAIM.

11. INSURANCE

11.1 During the Term, Beamery shall, at its own cost and expense, obtain and maintain, comprehensive insurance to cover its potential liabilities to Customer and such insurance as is legally required and appropriate to its business. All insurance policies are placed with insurers rated equivalent to "A-" or better by A.M. Best.

12. MISCELLANEOUS

- 12.1 **Notices**. Any notice or other communication required to be given under this Agreement shall be in writing and shall be delivered by email, in the case of Beamery to contract.notices@beamery.com. If such email is sent on or after 5:00pm on a business day, or on a day that is not a business day, it will be deemed served at 9:30am the next business day.
- 12.2 **Export Controls**. In the event that the Services are subject to applicable U.S., UK, or EU export control and economic sanctions laws, the parties agree to comply strictly with all such domestic and international export laws and economic sanctions regulations as they apply to the Services or use thereof, and to the extent consistent with the Agreement, to obtain any necessary license or other authorization to export, re-export, or transfer the Services.
- 12.3 **References**. Upon go-live of the Services and at the reasonable request of Beamery, Customer shall provide references to potential customers of Beamery.

- 12.4 **No Waiver.** No failure or delay by a party to exercise any right or remedy, in whole or in part, provided under this Agreement or by law shall constitute a waiver of that or any other right or remedy, nor shall it prevent or restrict the further exercise of that or any other right or remedy.
- 12.5 **Severance**. If any provision or part-provision of this Agreement is or becomes invalid, illegal or unenforceable, it shall be deemed modified to the minimum extent necessary to make it valid, legal and enforceable. If such modification is not possible, the relevant provision or part-provision shall be deemed deleted. Any modification to or deletion of a provision or part-provision under this Section shall not affect the validity and enforceability of the rest of this Agreement.
- 12.6 **Entire Agreement**. This Agreement and its exhibits contain the whole agreement between the parties relating to the subject matter hereof and supersedes all prior agreements, arrangements and understandings between the parties relating to that subject matter. Beamery may amend this Agreement from time to time, in which case the new Agreement will supersede prior versions.
- 12.7 **Third Party Rights**. Other than the Reseller who may enforce this Agreement on Customer, nothing in this Agreement, express or implied, is intended to or shall confer upon any third-party person or entity any right, benefit or remedy of any nature whatsoever under or by reason of this Agreement or under the Contracts (Rights of Third Parties) Act 1999 (to the extent applicable).
- 12.8 **Relationship of the Parties**. Nothing in this Agreement is intended to, or shall be deemed to, establish any partnership or joint venture between any of the parties, constitute any party the agent of another party, or authorize any party to make or enter any commitments for or on behalf of any other party.
- 12.9 Assignment. Neither party shall assign any of their rights or obligations under this Agreement without the prior written consent of the other party, which consent shall not unreasonably be withheld. However, consent is not required for an assignment of this Agreement by Beamery in connection with a change of control, merger, stock transfer, sale or other disposition of substantially all the assets of the assigning party's business. This Agreement will bind and inure to the benefit of each party's successors and assigns. Under the terms of the Reseller Agreement, Customer's Purchase Order with Reseller may be assigned to Beamery without Customer's consent; if such assignment occurs, Customer's access and use the Service shall be subject to Beamery's then standard Main Services Agreement at https://beamery.com/terms-and-conditions/ and Customer consent to the application of such terms and conditions, including without limitation, the billing and payment provisions contained therein.
- 12.10 **Force Majeure**. Except for Customer's payment obligations, neither party shall in any circumstances be in breach of this Agreement nor liable for delay in performing, or failure to perform, any of its obligations under this Agreement if such delay or failure results from an event of Force Majeure. If the Force Majeure event prevents the affected party's performance of its obligations for a continuous period of more than four (4) weeks, the party not affected by the Force Majeure event may terminate this Agreement by giving one (1) week's written notice to the affected party.
- 12.11 **Survival**. In addition to any provisions that expressly survive, the following provisions shall survive the expiration or termination of this Agreement: <u>Sections 5</u> (*Termination & Suspension*), <u>6</u> (*Proprietary Rights*), <u>7</u> (*Confidentiality*), <u>8</u> (*Data Protection & Security*), <u>10</u> (*Limitation of Liability*), <u>12</u> (*Miscellaneous*), and <u>13</u> (*Governing Law & Jurisdiction*).
- 12.12 Interpretation. A reference to a statute or statutory provision is a reference to it as amended, extended, or re-enacted from time to time.
- 12.13 **Authority.** Each party confirms that it has the legal power and authority to, and hereby does, enter into this Agreement in accordance with applicable law and with all due authority.

13. GOVERNING LAW AND JURISDICTION

- 13.1 If Customer is located outside of North America: This Agreement and any dispute, or claim arising out of or in connection with it shall be governed by and construed in accordance with the laws of England, and the parties consent and submit to the exclusive jurisdiction of the courts of England for any litigation arising out of or relating to this Agreement.
- 13.2 If Customer is located within North America: This Agreement and any dispute, or claim arising out of or in connection with it shall be governed by and construed in accordance with the laws of the state of New York, and the parties consent and submit to the exclusive jurisdiction of the courts of New York, New York for any litigation arising out of or relating to this Agreement.

EXHIBIT 1 - DATA PROCESSING AGREEMENT

1. DEFINITIONS

- 1.1 **Controller**, **Processor**, **Data Subject**, **Personal Data**, **Processing** (and **Process**) and **Personal Data Breach** shall have the meanings given in the GDPR, or the material equivalent under other applicable Data Protection Law.
- 1.2 **Restricted Transfer** means a transfer of Personal Data from the European Economic Area or UK (as applicable) to a country outside of the European Economic Area or UK (as applicable) which is not subject to an adequacy determination.
- 1.3 Standard Contractual Clauses or SCCs means the contractual clauses annexed to the European Commission's Implementing Decision 2021/914 of 4 June 2021 on standard contractual clauses for the transfer of personal data to third countries pursuant to Regulation (EU) 2016/679 of the European Parliament and of the Council ("EU SCCs") or the UK Addendum to the EU SCCs issued by the UK Information Commissioner's Office, as applicable. Completed SCCs can be found at <u>https://beamery.com/terms-and-conditions/</u>.
- 1.4 **Data Privacy Framework** means the EU-US and/or Swiss-US Data Privacy Framework self-certification program operated by the US Department of Commerce.
- 1.5 Data Privacy Principles means the Data Privacy Framework principles (as supplemented by the Supplemental Principles).

2. PERSONAL DATA PROCESSING

- 2.1 Beamery shall process Personal Data on Customer's behalf to perform its obligations under this Agreement and, as such, Customer is the Controller and Beamery is the Processor for the purposes of the Data Protection Law. <u>Annex 1</u> sets out the details of the data processing to be undertaken by Beamery.
- 2.2 Customer can use the Services to assist it with its obligations under the GDPR, including its obligations to respond to requests from Data Subjects. Taking into account the nature of the processing, Customer agrees that it is unlikely that Beamery would become aware that Customer Data transferred under the Agreement is inaccurate or outdated. Nonetheless, if Beamery becomes aware that Customer Data transferred under the Agreement is inaccurate or outdated, it will inform Customer without undue delay. Beamery will cooperate with Customer to erase or rectify inaccurate or outdated Customer Data transferred under the Agreement by providing the tools within the Services so that Customer can use it to erase or rectify Customer Data.
- 2.3 Each party will comply with all applicable Data Protection Law.

3. BEAMERY OBLIGATIONS

- 3.1 Beamery shall, in relation to any Personal Data processed by Beamery in connection with the performance of its obligations under this Agreement:
 - a) Process Personal Data only for the purpose of fulfilling the terms of the Agreement and only on the documented instructions of Customer, unless otherwise required to do so under applicable Data Protection Law.
 - b) Ensure that each of its employees, agents, subcontractors, Sub-Processors or any persons acting under the authority of Beamery are made aware of Beamery's obligations with regard to the confidentiality of the Personal Data and require that they enter into binding obligations with the Beamery in order to maintain such confidentiality.
 - c) Assist Customer in ensuring compliance with the Customer's obligations pursuant to applicable Data Protection Law in respect of security of processing, notification of Personal Data Breaches to the appropriate supervisory authority, communication of Personal Data Breaches to the Data Subject, data protection impact assessments and prior consultation with the appropriate supervisory authority where appropriate.
 - d) Make available to the Customer all information necessary to demonstrate compliance with Article 28 of the GDPR and allow for and contribute to audits (subject to <u>Section 6.3</u> below).
 - e) Promptly notify the Customer if, in its opinion, it is asked to do something that infringes Data Protection Laws.
 - f) Maintain a record of all categories of processing activities carried out on behalf of the Customer.
 - g) Where applicable, cooperate with the appropriate supervising authority in the performance of its tasks.
 - h) Not Sell (as defined in the CCPA/CPRA) any Personal Data.

4. DATA DELETION

4.1 Customer may export copies of Personal Data in .csv format at any time during the Term. Beamery shall delete all Personal Data in the production environment within 30 days of termination or expiration of the Agreement and all existing backups within 90 days thereafter unless applicable Data Protection Law requires storage of the Personal Data or as otherwise agreed between the parties. Beamery will provide a certification of deletion of Personal Data (as described in clause 8.5 of the SCCs) upon Customer's written request.

5. DATA SUBJECT RIGHTS

5.1 Beamery shall assist Customer in the fulfilment of Customer's obligation to respond to or action a Data Subject request under Data Protection Law. If a Data Subject makes a request to Beamery, Beamery will forward such request to Customer without undue delay. Customer authorizes Beamery to respond to any Data Subject who makes a request to Beamery, to confirm that Beamery has forwarded the request to Customer. 5.2 Beamery shall notify Customer without undue delay following confirmation of a Personal Data Breach. The notification will include, to the extent such information is available: (a) the nature of the Personal Data Breach including where possible, the categories and approximate number of Data Subjects concerned and the categories and approximate number of Personal Data records concerned; (b) the name and contact details of the data protection officer or other contact point where more information can be obtained; (c) the likely consequences of the Personal Data Breach; (d) the measures taken or proposed to be taken by Beamery to address the Personal Data Breach, including, where appropriate, measures to mitigate its possible adverse effects. Where, and in so far as, it is not possible to provide the information at the same time, the information may be provided in phases without undue delay. Customer agrees that an unsuccessful security incident will not be subject to this Section. An unsuccessful security incident is one that results in no unauthorized destruction, loss, alteration, disclosure of, or access to Customer Data or Customer's Personal Data or to any of Beamery's equipment or facilities storing Customer Data.

6. SECURITY MEASURES AND AUDITS

- 6.1 In providing the Services, Beamery shall at all times, taking into account the nature, scope, context and purposes of the processing, the level of risk and severity for the rights and freedoms of natural persons that might result from a Personal Data Breach, technological developments, and the costs of implementing any measures, implement technical and organizational measures to protect against a Personal Data Breach, including as set out in <u>Annex 2</u>.
- 6.2 Beamery shall ensure that the security of Personal Data is protected by recognized industry standard policies and procedures (not less than set out in this DPA) and reliable, well-trained staff.
- 6.3 Upon Customer's request, and subject to the confidentiality obligations set forth in the Agreement, Beamery shall make available to Customer information regarding Beamery's compliance with the obligations set forth in this DPA in the form of third-party certifications. Beamery and Customer agree that such demonstration of compliance by Beamery is the preferred mechanism for meeting the requirements of Article 28(3)(h) of the GDPR and the SCCs. To the extent that Customer (acting reasonably) is not satisfied with such demonstration of compliance, Beamery may allow for and contribute to audits, by or on behalf of Customer in relation to the processing of the Customer Personal Data. Customer may contact information.security@beamery.com to request a remote audit of the procedures relevant to the protection of Personal Data, provided that Customer may not exercise this right more than once per year. Before the commencement of any such remote audit, the parties shall mutually agree upon the scope, timing, and duration of the audit. Customer shall promptly notify Beamery with information regarding any non-compliance discovered in an audit. Such audit shall not require Beamery to disclose to Customer any data or information relating to Beamery's other customers or Beamery's internal accounting, or any data information that, in Beamery's reasonable opinion, could compromise its security or cause Beamery to breach its obligations to a third party.

7. ONWARD TRANSFERS

- 7.1 In connection with the Services, the parties anticipate that Beamery (and its Sub-Processors) may process Personal Data outside of the European Economic Area (EEA), Switzerland, the UK, or the country where Customer, Authorized Users, or Contacts are located. The parties agree that when a transfer of Personal Data under this Agreement is a Restricted Transfer it shall be subject to the appropriate transfer mechanism. Processor shall not (nor permit any Sub-Processor to) make a Restricted Transfer unless the Restricted Transfer is made in compliance with applicable Data Protection Laws.
- 7.2 **Transfer mechanisms for data transfers.** If, in the performance of the Services, Personal Data that is subject to Data Protection Laws that apply in EEA/UK/Switzerland is transferred out of such regions to countries which do not ensure an adequate level of data protection within the meaning of the applicable Data Protection Laws, the transfer mechanisms listed below shall apply to such transfers and can be directly enforced by the Parties to the extent such transfers are subject to the Data Protection Laws.
- 7.3 **Data Privacy Framework.** To the extent Beamery Inc. processes any Personal Data via the Services originating from the EEA/UK/Switzerland, Beamery represents that Beamery Inc. is self-certified under the Data Privacy Framework and complies with the Data Privacy Principles when processing any such Personal Data. To the extent that Customer is (a) located in the United States of America and is self-certified under the Data Privacy Framework or (b) located in the EEA or Switzerland, Beamery further agrees: (i) to provide at least the same level of protection to any Personal Data as required by the Data Privacy Principles; (ii) to notify Customer in writing, without undue delay, if its self-certification to the Data Privacy Framework is withdrawn, terminated, revoked, or otherwise invalidated (in which case, an alternative transfer mechanism will apply in accordance with applicable Data Protection Laws); and (iii) upon written notice, to work with Customer to take reasonable and appropriate steps to stop and remediate any unauthorized processing of personal data.
- 7.4 **Transfers from the EEA**. In relation to Personal Data protected by the EU GDPR that is not covered under the Data Privacy Framework, the EU SCCs will apply completed as follows:
 - a) Module Two will apply.
 - b) in Clause 7, the optional docking clause will apply;
 - c) in Clause 9, Option 2 "General Authorization" will apply, and the time period for prior notice of Sub-Processor changes shall be as set out in <u>Section 8</u> of this DPA;
 - d) in Clause 11, the optional language will not apply;
 - e) in Clause 17, Option 1 will apply, and the EU SCCs will be governed by German law;
 - f) in Clause 18(b), disputes shall be resolved before the courts of Germany;
 - g) Annex I of the EU SCCs shall be deemed completed with the information set out in Annex 1 to this DPA;
 - h) Annex II of the EU SCCs shall be deemed completed with the information set out in <u>Annex 2</u> to this DPA; and

- i) Annex III of the EU SCCs is not needed as the parties have agreed to general authorization of sub-processors.
- 7.5 **Transfers from UK**. Where a Restricted Transfer is made from the UK, the UK Addendum is deemed executed between Customer and Beamery and the EU SCCs (as modified above) shall apply as amended by the UK Addendum.
- 7.6 **Transfers from Switzerland**. Where a Restricted Transfer is made from Switzerland in relation to data that is protected by the Swiss Federal Act on Data Protection, the EU SCCs (as modified above) are incorporated into this DPA, except that:
 - a) in Clause 13, the competent supervisory authority is the Swiss Federal Data Protection and Information Commissioner;
 - b) references to "Member State" shall refer to Switzerland; and
 - c) references to the "General Data Protection Regulation," "Regulation 2016/679," and "GDPR" in the EU SCCs shall refer to the Swiss Federal Act on Data Protection (as amended or replaced).
- 7.7 **Conflict**. If any provision of this DPA is inconsistent with any terms in the Agreement, this DPA will prevail. If any provision of this DPA is inconsistent with any terms in the SCCs, the SCCs will prevail.

8. SUB-PROCESSORS

- 8.1 Customer provides general authorization to Beamery appointing the Sub-Processors set out at https://beamery.com/termsand-conditions (as amended from time to time with prior written notice to Customer) as third-party processors of Personal Data under this Agreement. Before each Sub-Processor processes Personal Data, Beamery shall: (a) carry out due diligence and enter into written contract with the Sub-Processor to ensure that the Sub-Processor shall provide the same level of protection for Personal Data as required by this DPA and Article 28(3) of the GDPR; and (b) if that arrangement involves a Restricted Transfer, ensure that such Sub-Processors have an appropriate transfer mechanism in place.
- 8.2 Customer may reasonably object to Beamery's use of a new Sub-Processor by notifying Beamery promptly in writing within fourteen (14) days of Beamery's notice. In the event Customer, acting reasonably, objects to a new Sub-Processor, Beamery will use commercially reasonable efforts to make available or recommend to Customer a change in the Services or configuration or use of the Services to avoid Processing of Personal Data by the objected-to new Sub-Processor without unreasonably burdening Customer. Customer acknowledges that any objection to a new or alternative Enrichment Data (as defined in Section 1 of the Agreement) providing Sub-Processor will prevent the provision of such Enrichment Data, and this shall not constitute a breach of the Agreement by Beamery.
- 8.3 Beamery shall remain liable for all acts or omissions of all Sub-Processors to the same extent Beamery would be liable if performing the services of each Sub-Processor directly under the terms of the Agreement.

9. GOVERNMENT ACCESS REQUESTS

In its role as a Processor, Beamery shall maintain appropriate measures to protect Personal Data in accordance with the 9.1 requirements of Data Protection Laws. If Beamery receives a legally binding request to access Personal Data from a law enforcement agency, Beamery shall, unless legally prohibited: (a) promptly notify Customer including a summary of the request; (b) inform the requesting government authority that Beamery is a service provider and it is not authorized to disclose the Personal Data; (c) inform the requesting government authority that all requests for the Personal Data must be sent to Customer; and (d) not provide access to the Personal Data unless authorized by Customer in writing. To the extent Beamery is prohibited by law from providing such notification, Beamery shall use commercially reasonable efforts to obtain a waiver of the prohibition to enable Beamery to communicate to Customer as much information as possible, as soon as possible. Further, Beamery may challenge the request if, after careful assessment, it concludes that there are reasonable grounds to consider that the request is unlawful. Beamery may pursue possibilities of appeal and may request Customer to cover expenses for such appeal. Beamery shall promptly notify Customer if Beamery becomes aware of any direct access by a Public Authority to Personal Data and provide information available to Beamery, to the extent permitted by law. For the avoidance of doubt, this DPA shall not require Beamery to pursue action or inaction that could result in civil or criminal penalty for Beamery. Beamery shall not disclose Personal Data in a massive, disproportionate, and indiscriminate manner that goes beyond what is necessary in a democratic society. Beamery shall ensure that Sub-Processors involved in the processing of Personal Data are subject to the relevant commitments regarding government access requests in the SCCs. Beamery shall ensure that Sub-Processors are subject to the relevant commitments regarding such government access requests.

- 1.2 **Grow User Data** means the Personal Data input by or belonging to a Grow User for the purpose of using the Grow Services. Grow User Data is not "Customer Data". For clarity, all other data input into the Grow Services by Customer, such as gigs, jobs, company information, and referrals shall be "Customer Data".
- 1.3 **Grow Services** means Beamery's proprietary mobility, career pathing and progression platform that Beamery provides pursuant to this Agreement and further described in the applicable Resale Order. Grow Services shall be added to the definition of "Services" and such terms of the Agreement shall apply to the Grow Services unless otherwise stated here.

2. DATA PROCESSING

- 2.1 **Ownership of Grow User Data.** Each Grow User remains the sole owner of its own Grow User Data. Beamery's processing of the Grow User Data is determined and controlled by the Grow User at its sole discretion.
- 2.2 **Deletion of Grow User Data.** Beamery will delete the Grow User Data in accordance with the separate agreement with the individual Grow User. For clarity, Beamery will delete all Customer Data in accordance with the Agreement.
- 2.3 Annex 1 of the SCCs. For the purposes of Annex 1 of the SCCs
 - a) under Section A, Beamery is a Processor of Grow User Data for the duration of the Term. Thereafter, Beamery is the sole Controller of Grow User Data.
 - b) under Section B, the period for which the personal data will be retained for the Grow User Data shall be in accordance with the separate agreement with that Grow User. For clarity, Customer Data is processed as stated in Section B of Annex 1 of the SCCs.
- 2.4 **Annex 2 of the SCCs**. Any references to deletion of Grow User Data will be replaced with the deletion terms of the separate agreement with that Grow User.
- 2.5 **Sub-Processors**. Sub-Processors for Grow are as identified in the Sub-Processor list.

Beamery does not permit any third party to use Customer Data to train the machine learning models utilzed by our provider Microsoft Azure or OpenAI, for clarity, no Customer Data is accessed by OpenAI or Microsoft. You acknowledge that Beamery may utilize Feedback or Customer Data submitted to the TalentGPT Service(s) for the purpose of developing and improving the TalentGPT Service(s), and any other of Beamery's current and future similar or related features, products and/or services.
- 4. Privacy Guidance. If Customer submits Personal Data to TalentGPT, Customer must provide legally adequate notices and Customer represents and warrants that Customer will process such Personal Data in accordance with Applicable Laws, including a lawful basis for such processing. Sensitive Personal Data may not be submitted to TalentGPT. Customer may not use TalentGPT to create or analyze biometric identifiers. nor for the purposes of analyzing, profiling, or targeting someone's status in a protected class.
- 5. DISCLAIMER. Beamery does not make any warranty as to the Output or any results that may be obtained from the use of TalentGPT or the accuracy of the Output or any other information obtained through TalentGPT. Customer understands and agrees that the use of TalentGPT, Output, and any other information obtained through the use of TalentGPT is done at Customer's sole discretion. Customer should not rely on factual assertions in Output without independently fact-checking their accuracy. Output that appears accurate because of their detail of specificity may still contain material inaccuracies. No information or advice, whether oral or written, obtained by Customer through TalentGPT shall create any warranty not expressly made in the Agreement.
- 6. Service Level Agreement Not Applicable. Notwithstanding anything in the Agreement or the SLA, the unavailability of TalentGPT features will not be included in Beamery's Uptime or Downtime calculations.
