Common Anti-Bullying Laws

Strategies for protecting a person who reports bullying and/or provides information

Prompt notification of parents or guardians of both victim and perpetrator about reports of, responses to, and prevention of further bullying; criminal behavior will be reported to local law enforcement

Students knowingly making false accusations of bullying will be subject to disciplinary action

Plan to offer counseling and/or referrals to counseling for victims, perpetrators, and their families

The plan shall be updated biennially

Common Anti-Bullying Laws

Internet safety issues as related to cyber bullying

Annual written notice to staff of bullying prevention and intervention plan

Faculty and staff shall be trained annually on the school's bullying prevention and intervention plan

Faculty and staff duties outlined in the plan shall be included in employee handbook

Parent Education

Common Anti-Bullying Laws

Plan shall include provisions for educating parents about the bullying prevention curriculum, including home reinforcement of curriculum, dynamics of bullying and online safety, and cyber-bullying

Annual written notice to students and parents of bullying prevention and intervention plan

Plan shall be posted on website of each school and/or district

Student handbook shall include age-appropriate summary of bullying prevention and intervention plan
