

Charter for Faculty Advisory Council, Graduate School USA

June 2020

Article I: Designation of Name

The name of this organization shall be the Graduate School Faculty Advisory Council (GSUSA FAC).

Article II: Purpose

The purpose of the GSUSA is to represent the interests of all GSUSA part-time faculty with GSUSA officials and other stakeholders. These interests shall include but are not limited to the following:

1. To address school-wide problems and concerns in a profession and collaborative manner.
2. To work with GSUSA leadership team to advance the spirit of the Faculty Charter and the mission of the School.
3. To promote an innovative teaching experience for faculty and a supportive learning environment for students.
4. To provide guidance in areas including curriculum, training, new initiatives and professional development, among others.
5. To offer recommendations for instructional programs and provide information relevant to policy to the administration, and ensure a strong, effective and collaborative-working relationship between the School and its faculty.

Article III: Membership

Each member has a common, shared interest in contributing to the success of the School and the development of talent in the public sector communities we serve. Membership shall be open to any person who has taught for GSUSA within the last five years with a satisfactorily performance record.

7. Support business development opportunities as SMEs: face-to-face visits, calls, and social media efforts tied to the student experience through twitter, Facebook, LinkedIn, etc.
