Yes, this is very attractive because depending on the years purchased, the license becomes discounted.

#### 14. Can I update the term license through the Software License Utility?

Yes, if the order for extension or renewal has been processed, you can update the expiry date by a single button click on "Upgrade License".

#### 15. Would I get a warning message in POSPac before license expiration?

You will receive a notification at the start of every session that uses the licensed function, beginning 150 days before the license expires.

#### 16. Does the term license need to be contiguous?

No.
