Dear Friends,

2020 will be remembered by many as a year full of challenge, solitude and loss. But it was also a year of unusual silver linings, of rising to the

challenge and of creatively finding new ways to communicate and to live.

The hallmark of RTA is creating community by being in proximity with each other inside and outside of prison. The loss of being together physically was deeply felt by our members, teaching artists, alumni, staff and board.

As I write this letter in June 2021, we are gradually returning to prison, meeting with members and scheduling fall in-person workshops. I am glad to say the RTA community remains intact and, in some ways, even stronger than before.

Here is a glimpse at how RTA navigated 2020:

- In January we produced two productions— Father Comes Home from the Wars at Green Haven Correctional Facility and Dutch Crown, written by alumnus Philip Hall, at Woodbourne Correctional Facility—without knowing these would be our last productions for more than a year and a half.
- In March the pandemic hit abruptly, and all NYS prisons were closed to community-based programs. Teaching artists guickly pivoted to developing paper lessons in all art forms, which we delivered to DOCCS personnel in prison parking lots.
- In April, we were given an opportunity to communicate with our members by secure messages, the prison version of email, through JPAY, the prison version of tablets. We also received permission to hold weekly conference calls with senior RTA participants at each facility.

- Throughout the year we continued to refine distance learning through audio cassette and DVD lessons. Through secure messaging, we sent lessons in poetry, memoir, playwrighting, monologues and visual arts, addressing the specific needs of each individual member.
- In December we presented Lulu, I Hear You... Messages from the Inside During Covid-19, a virtual event in which RTA alumni and teaching artists shared writings from RTA incarcerated members.
- Through the year we stayed busy with countless Zoom meetings, virtual panels, work on a new website, social media campaigns, updated logo and messaging along with training for our teaching artists in Diversity, Equity and Inclusion and Culturally Responsive Education.

While 2020 was a truly difficult year for our members, who experienced far greater isolation and distress than those of us on the outside, I was overwhelmed by their resilience and by the beautiful art they continued to create. I am deeply grateful to everyone who helped keep RTA's mission strong by lending your time, generosity and encouragement-and I can't wait to see you in person soon!

Breaking the Cycle of Incarceration

There are 1.8m people incarcerated in the US. Over 95% will eventually be released.

RTA members use their time productively in prison, and when released reconnect with their families and strengthen their communities, breaking a generational cycle.

Saving Money

The US spends over \$80 billion a year on incarceration.

RTA's proven impact on recidivism saves taxpayers millions of dollars each year.

Diversity, Equity & Inclusion

As an organization that works extensively with incarcerated people, we stand in solidarity with all people of color and all those oppressed by institutional inequality. As an arts organization, we are committed to telling the story of our shared humanity.

While structural racism and inequality are ingrained in every aspect of our society, these forces are particularly destructive in the criminal justice system. While RTA is not primarily an advocacy organization, we do have a role to play in countering racism and inequality.

Shifting the system from punishment to rehabilitation The current prison system in the US is based on punishment, with roots in a slavery-era society. Through our creative arts program, we work towards and advocate for an approach based on human dignity rather than punishment.

Changing the narrative We believe creating community support is an essential precursor to changing policy. We strive to create a platform for our alumni and incarcerated members to share their voices and for our community participants, alumni, teaching artists, supporters, audience members—to challenge long-held assumptions about each other.

Reflection and change We recognize that no one, and no organization is immune from the impact of institutionalized racism, and we are committed to holding ourselves to the highest standards. We offer regular DEI trainings for our staff, board of directors, and teaching artists, and we are committed to diversity, equity, and inclusion at all levels of our organization.
