Q: What does “dry dampness” and “clear heat” refer to in TCM?

A: In TCM, “dampness” is understood as an internal imbalance related to excess moisture, which may contribute to sensations of heaviness, sluggishness, or swelling. “Heat,” in TCM, refers to a state of excess that can manifest as restlessness or discomfort. These concepts are part of a holistic framework that emphasizes restoring balance through diet and herbal support. From a Western perspective, these ideas can be loosely compared to inflammation and fluid retention—physiological responses that, when elevated, may affect overall well-being. While the terminology differs, both approaches recognize the importance of supporting the body's natural processes to maintain health and vitality.

Q: How does Alpha 20C® aid digestion?

A: Alpha 20C® contains a blend of herbs traditionally used in Herbal Medicine and TCM. One of its key ingredients, dandelion root, is a source of inulin—a type of soluble fiber that helps support the growth of beneficial intestinal bacteria. Dandelion root is also traditionally used in Herbal Medicine to help relieve digestive disturbances such as dyspepsia.

HOW TO USE

Capsule - Adults: Take 4 capsules 3 times daily. If used as a diuretic: For occasional use only.

Powder - Adults: Mix 1 package with 250 mL of water, take twice daily. Consult a health care practitioner for usage beyond 2 weeks or to modify your dose for long term use.
