## 2.4 Recall Advisory Group Purpose

- Co-Chairs: Andrea Currie (Coles), Lily Rattanaphasouk (Goodman Fielder) terms expired
- Next term commences 1st June 2021 1st June Mar 2023. Melanie advised that nominees for both co-chair roles are still pending confirmation and that they will be motioned forward to the group for ratification as soon as possible, via email poll prior to the next meeting in September.
- Basis for nomination of co-chairs is that they represent both the sponsor and recipient community as well as balance geography by being from separate states. As we are now holding the meetings virtually the geography is not a problem.

- Subscriber onboarding 97% live (9 outstanding)
- (New) Mock notifications tracking well, shows companies are keeping on top of training and annual ready/live process
- 8 recalls listed on FSANZ site, none were Recall subscribers

- Melanie advised that the Recall Hub has now been split into he the respective Healthcare and Food & Consumer Goods Hubs and that the link above will provide access

## 2.7 Recall Development Roadmap

Roadmap update - delivered by Chris Drougas, GS1 Australia

- 2 releases per year
- Release 1 (R1) May 29th deployed
  - 16 requirements submitted and 3 directly related to the WA Health rollout.
     The focus is on UI improvements and workflow improvements, also improvements for the WA Health Structure.
  - New changes were made which created a new colour palette with increased contrast levels allowing for better navigation.
  - There is a new notification summary via the UI
- Release 2 (R2) for 2021 is due November 2021
  - R2 to focus on changes to the workflow in the Food & Consumer Goods portal and updates to post recall reporting for FSANZ

## 2.8 Issues / Challenges / Opportunities

Delivered by Chris Drougas, GS1 Australia

There were no issues raised

#### **Regulatory Updates**

Michael Smith - FSANZ provided an update to the Recall Protocol

- There were discussions around the comments from the review and how recalls are
  notified for NZ if Australian exports. The GS1 portal can be used to advise NZ
  companies if you add them in as a non-subscriber. Foodstuffs in NZ makes it
  compulsory to add recall notification for them via the GS1 NZ recall portal. This
  cannot be done via the GS1 Australian Portal however, Andrew Brown advised that
  there are some discussions around Global Jurisdictions and online retailers for
  parallel imports.
- You can tick that a product has been exported to NZ in the portal. Michael advised that FSANZ would notify NX if a recall has been raised in Australia. If the Recall is released in NZ for a product exported to Australia, FSANZ will notify the jurisdictions and it is there responsibility as to whether a recall or withdrawal is required
- Michael advised that recall communications via print media is not mandatory in the new Recall Protocol, however, social media and publications are recommended.

ACTION: GS1 and the co-chairs will invite presenters based on these topics for future meetings.

#### 2.9 General Business

#### Marketing Activity

Tracey Kelly-Jenkins provided an update to the Recall marketing, communications, editorials and advertising

The May Recall Bootcamp had 105 registrations and resulted in 39 Recall webinar bookings

Giveaway on social media - expand awareness and knowledge of the recall platform using alternate marketing tactics such as giveaways (Done via social media). This has resulted in 21 new followers and has a 14% engagement rate

The LinkedIn Paid campaign has resulted in 61 website visits and the showcase page for Recall has a 200% increase in followers, corresponding with the latest Bootcamp session.

- Melanie advised that the NGTAG Newslink was circulated and asked for the Advisory Group to share with their network. An update on the NGTAG work programs, Steering Committee Members and membership was provided. A video interview from Samantha Blake from NGTAG Steering Committee was provided to the group highlighting why the AFGC is involved, what traceability means to them and for industry.
- Andrew Steele advised that Woolworths has sent communications to some of their suppliers advising that they can now scan 2D Barcodes across all of their stores.
   Andrew suggested that we invite Woolworths to talk about what this means at our next meeting

GS1 will review current members and invite new members - ongoing



 GS1 provided a comparison between Recalls in on FSANZ webpage, vs usage of portal and subscribed Recall portal users. GS1 will continue to maintain this comparison on an ongoing basis.

GS1 advised that the revised traceability framework GTS2 has been ratified and released. In addition, GS1 has also ratified and published a generic industry sector traceability guidelines template document and a guideline for Fish Traceability (Europe) which can be used as a sample of a completed and ratified sector-based traceability guideline.

Marcel Sieira from GS1 presented an update of relevant current industry initiatives

Association involvement – ACCC has asked to be removed from the Advisory Group invitations.

GS1 will continue to send meeting minutes as a courtesy.

It was noted that the release timeframes provided too short notice.

 GS1 have negotiated longer timeframes for UAT with developer allowing users time to book UAT session in their calendars. GS1 has negotiated longer UAT period

GS1 will provide data and stats as pre reading work to shorten the duration of reporting. GS1 will only report on highlights and anomalies if required.

New feature demonstrations/presentations on industry topics maybe added to forums

Stakeholders were in favour of reviewing a message of support or endorsement for the portal. GS1 Aust. will draft up the sample endorsement for review. This endorsement will be used as information for potential and new users, also existing users to reaffirm their engagement with the system.

- The Recall Endorsement letter has had 10 positive responses; 3 customers have advised they will not (main reason is these companies usually don't endorse products or services outside of their company range) and 11 companies are yet to formally respond.
- o GS1 will use the endorsement as it currently has 10 supporters
- GS1 to include this endorsement as part of the onboarding of significant new subscribers (e.g. Caltex)
- Endorsement letter is now "in production" however stakeholders can be added at any time

Foodbank update – In December 2018 / January 2019, GS1 and Foodbank will discuss impact of discussions held by Michael Davidson (Foodbank) and other AG Members such as Simplot. Effort is still required to further understand the operational process when a donation occurs. And to also explore the different process that occurs for undeclared allergen versus foreign matter contamination.

 GS1 And Simplot to review above in January; findings to be tabled at AG in June



 GS1 has added the Foodbank contact details within the portal to enable users to directly contact foodbank in addition to them receiving the notice.

GS1 will be providing facilities for the AIFST workshop on product recall in Melbourne on 28 February 2019 – Relevant guest speakers will be completing a briefing before the meeting and Recall will be a feature within the workshop.

 AIFST event was successful with Fiona Fleming, (AIFST) Andrew Brown (GS1) and Peter McGee (Victual) presenting. GS1 have started discussions for opportunity to hold the event around Australia on a regular basis.

GS1 were well received at the presentation for the NRA product safety technical committee in October. Discussions around contacting consumers via publications and newspapers occurred. The case study from WD-40 has been published and was distributed at NRA conference.

## **5.1 Trade Practices Compliance Notice**

Participants on GS1 Boards, committees, task forces, work groups, or other similar bodies, must always remember the purpose of the Board, committee task force, or work group is to enhance the ability of all industry members to compete more efficiently and effectively to provide better value to the consumer or end user. GS1 activity almost always involves the cooperation of competitors; therefore, great care must be taken to assure compliance with trade practices laws in Australia and in other jurisdictions. (Including the Australian Consumer Law, the Competition and Consumer Act and state based Fair Trading Legislation).

#### This Means:

- Participation must be voluntary, and failure to participate shall not be used to penalise any company.
- There shall be no discussion of prices, allocation of customers or products, boycotts, refusals to deal, or market share. (For the avoidance of doubt, this does not preclude discussion of GS1 Australia's prices, customers or products.)
- If any participant believes the group is drifting toward impermissible discussion, the topic shall be tabled until the opinion of lawyer(s) with experience in trade practices law can be obtained.
- Where appropriate, meetings shall be governed by an agenda prepared in advance, and recorded by minutes prepared promptly after the meeting.
- Where appropriate, tests or data collection shall be governed by protocols developed by GS1 Australia.
- GS1 reserves the right to seek opinion of lawyer(s) with trade practices experience on any matter or document arising out of any GS1 activity.
- The recommendation coming out of a GS1 Board, committee, task force, work group or task group are just that. Individual companies remain free to make independent, competitive decisions.
- Any Standards developed must be voluntary standards.
