5. Confirmation of Co-Chair Nominations/Co-chair position(s)

- Rob Setina, HPV had nominated. Group confirmed him as Co-Chair of HCNPCAG. This will take
 effect from next meeting.
- Call out to the group for additional nominations.

ACTION (1.2) – Gary Russon to discuss with Elizabeth (included within action from Kick off meeting as this is ongoing).

6. Simplification, Quality & usability improvements

a. Dataset Review – Copy of supplementary Terms of Reference and process were provided as pre-reads. An overview (background, roles and objectives) were presented for group awareness (per slides 15-16) and request for participation in working group. Focus of this process is to try to help simplify the process for all of the user community and ensure that the dataset meets all expectations and needs of those using it. All HCNPCAG members will be



invited to participate in the review process in addition to other organisations from across the sector – this will include the TGA. Notification of the review to be published in Healthcare Industry newsletter for the visibility of the whole community. Proposed that the process commence in March and is concluded by May so that final discussion and approval of any changes can be undertaken at the AG meeting in May 2020.

ACTION (1.4) – GS1 to provide the details of the review to all HCNPCAG members and other invited participants and 'kick off' call to be scheduled. (included in action from kick off as ongoing)

- **b. NPC statistics** Murray Robb & Cath Koetz (GS1) talked through details of Australian NPC statistics and overview of the global use of GDSN presented to the group for discussion (per slides 15-16). Questions raised regarding who is using the data, what other health providers are being engaged.
 - **ACTION (2.3)** Further discussion in future meetings to ensure that this information is available. Recipient updates are a standing agenda item so will also continue to provide further detail.
- c. Extended User community details Discussion at kick off meeting included a request to get further insight into how and where the data from the NPC is being used. Question raised to AG members as to what they would like to see re statistics or details from the recipient community. Instead of more statistics the suggestion was raised for 'talking points' that summarise/ help to communicate how the NPC is used. Several recipients committed to sharing more detail at coming AG meetings.
 - **ACTION (2.1)** GS1 to work with AG members to develop an Executive level document providing talking points related to value of NPC for supplier organisations.
 - **ACTION (2.2)** Recipients to share details of their programs on an ongoing basis to the AG (within Recipient updates) and also aim to communicate this within their own programs
- d. Product Type segmentation reports Discussion within AG Kick off regarding wanting to understand more of the breakdown of products within the NPC. Question to AG members regarding what additional information they would like regarding product types (currently 'MedTech' and 'Pharma & Other' represented). No specifics were expressed by the AG so this will be closed as an action and can be raised again for discussion at future AG meetings.
- **e. Data Quality Improvement progress** Detailed statistics from the Data Quality program presented. Platinum suppliers as at mid-January 2020 59% which shows great progress by all involved.

7. General discussion/Updates

- a. AMT-CTPP (Australian Medicines Terminology Containered Trade Product Pack) Updates presented by Elizabeth Donohoo (ADHA) and Cath Koetz (GS1). Significant progress in the project to ensure all medications have AMT- CTPP and that they are loaded into NPC (per slide 23). Community engagement is ongoing.
- b. Recipient updates Rob Setina, HPV, presented an HPV Supply Chain Vision overview which included details of how they are currently and plan to use the NPC data across the state of Victoria. (per slides 25-33). Future updates will be provided in greater detail from other recipients at future meetings.

- c. **Discussion of additional items proposed by group members for consideration –** No addition items proposed for this meeting
- a. Global Data Model Cath Koetz (GS1) provided an overview of the GS1 Global Data Model to the group for awareness and questions. The project was initiated in the Grocery (food & non-food) sector to help to align how GDSN is being used globally. The initial project is now completed. A potential Healthcare project being discussed within Healthcare Global leadership team> As the global discussion progresses we will provide further updates, however note that the outcome of the Dataset review will feed into this process (per slide 35).
