NPC & AusUDID Sandpit – Brief Update

 AusUDID Sandpit is now live (start of July). TGA have worked with GS1 to draft a plan for piloting with suppliers who are using the NPC. First two users hoped to be live by end August, additional suppliers being sought to participate in the process (refer slides for more detail).

Review and Discussion of UNSPSC versions

Action 8.3

- Have been on v 19 for some time so have been looking at stats between v19 and v24. Only 32 GTINs affected = 4 suppliers
- 3 Options proposed to the group
 - $\circ~$ Stay as we are v19 to remain as the industry minimum requirement, V23+ to be 'allowed' where codes do not exist in v19.
 - Allow 2 versions v19 to remain as the industry minimum requirement, V24 to become specifically allowed as option (preferred?)
 - Transition whole sector to new Minimum Version v24 to become the industry minimum requirement, plan transition program
- If need to transition would need to plan for this to happen over at least 12-month period need to think about suppliers, recipients, and solution providers. Consider whether the new version can be accepted by recipients as change would have a significant impact due to existing mapping of attributes within recipient organisations
- Differences between V19 and V24 are they significant enough to make the change beneficial given the extent of the work in making the changes? Even though only 32 GTINs would be affected all GTINs would need to be reloaded
- Peter Wilson new version takes account of Covid we need to be flexible to take account of new developments
- Dolores Ternes change to versions will be a significant change so will be difficult to implement – is there a way to replace v19 with v24 code lists (like a find replace)? Seconded by Sarah Lankshear.
- Cath Koetz we will need to do more analysis as part of the decision-making process. How do
 we add the new codes that are more granular and useful? Do we need to change the version
 completely or can we do something in between? Can we implement a technical solution?
- Ramesh proposal of a solution that just manages the deltas between V19 and V24 so that we don't have to completely load another version
- Action make these issues a topic of deliberation by the subgroup.

There will still be the requirement for contracted items and these will be published directly to recipients. • Distributor Data Loading Item 2.3 - Murray Robb (Action 9.3 for tracking in Action Log) Initial meeting July 19th, 2022 Aim of this group is to provide clarity around areas of responsibility for different suppliers of data. Provided suggestions of who owns what elements of data but will need to send out a survey to receive feedback on all the fields under discussion. Need to seek feedback separately from some of the larger distributors. Action: GS1 will consolidate responses and feed back to the subgroup and get feedback on direction we should be taking. Murray Robb - challenge for distributor model is significant and will require a lot of co-ordination and co-operation to implement. Karen Eadie - is survey aimed at brand owners and distributors? Yes. Confirmation that the distributor is responsible as the primary contact with regard to provision of product data o Interim Load/Preliminary Item 2.2 - Murray Robb (Action 9.4 for tracking in Action Log) Initial meeting July 25th, 2022 Concept was welcomed by the sub-group (publishers & recipients), with agreement to poll members to better understand the types of attributes that can be difficult to source for a new item. A survey has been sent to sub-group members requesting that they list the attributes or groups of attributes that they

would like to see included within a Preliminary Item model.

	how their data is being used and this is important to ensure that suppliers
	continue to update their data. Proposals:

- Recipients to host short webinars to explain how data is being used
 - Long Lam how we currently use the data and how we could potentially use the data. Things like data lake could be used to showcase what is possible to highlight strengths of what the NPC could deliver eg. Example of rep visiting clients and being able to answer questions on site on the fly instead of having to come back later with the answers
- Clearer communication of how data is being used by recipients
- Other suggestions?
 - Sandy Giles team all very keen to look at how the NPC works from a recipient point of view to ensure that suppliers are aware of what recipients see and how they work.
 - Dolores Ternes need to reconcile data from recipients manually and compare to her own data on the NPC.
 - Cath Koetz is it necessary to ensure that recipients understand the process from a supplier point of view?
 - Peter Wilson important to resolve data alignment issues. The fact that manual templates are being used means that we aren't using the M2M solution. Is there merit in establishing a subgroup to explore data alignment between publishers and recipients?
