European Commission continues to release more guidance documents

As the MDR and IVDR regulation timelines continue within the European Union, additional guidance documents continue to be added to assist in clarifying implementation. The latest include:

- Guidance on appropriate Surveillance regarding the transitional provision under Article 120 of the MDR
- Verification of manufactured class D IVDs by notified bodies
- Updated guidance on performance evaluation of SARS-CoV-2 in vitro diagnostic medical devices.
