 - a) Data Set review As the data requirements are set by industry, the agreement for 3-year data set review cycle due in 2020 to ensure that the data requirements continue to meet industry needs. Review will focus on simplification of data set by product type (Medical Devices & consumables, Pharmaceuticals, InVitro Diagnostics, General Consumables) and revisit published Use Cases. Work to be completed within a working group reporting into Healthcare NPC Advisory Group.
